

**PERSONAL INTERVIEW FOR THE POST OF DEPUTY EXECUTIVE  
ENGINEER (CIVIL) ADVERTISED VIDE ADVT. NO. 02/2016**

Advertisements No. 02/2016 was published in the month of March 2016 for filling in various posts.

2. In pursuance of the recruitment process for the post of Deputy Executive Engineer (Civil) published vide Advertisement No. 02/2016 and the Notification dated 02.09.2016 and 17.11.2016, MSETCL conducted re-examination (On-Line Test) for the post of Deputy Executive Engineer (Civil) on 01.12 2016 in first phase.
