

**NOTIFICATION FOR INTIMATION OF RE-EXAMINATION (ON-LINE TEST) FOR  
THE POST OF “ASSISTANT ENGINEER (TRANS)” ADVERTISED VIDE  
ADVT. NO. 02/2016**

Vide notification under reference (1), the Company has cancelled the on-line tests conducted on 01.06.2016 to 03.06.2016 for the various posts advertised vide Advertisements No. 01/2016, 02/2016 & 03/2016. **It was decided to conduct re-examination of the candidates who had appeared for the aforesaid on-line tests.** It was also decided that re-examination (On-line Test) would be conducted in phase manner.

2. Accordingly, in the 1<sup>st</sup> Phase, re-examination (On-line Test) for the post of Deputy Executive Engineer (Civil) & Lower Divisional Clerk (Accounts) has been conducted on 01.12.2016 vide notification under reference (2) and in the 2<sup>nd</sup> Phase, re-examination (On-Line Test) for the post of Assistant Engineer (Telecom) & Assistant Engineer (Civil) has been conducted on 30.12.2016 vide notification under reference (3).

3. Now, in 3<sup>rd</sup> Phase, re-examination (On-line Test) for the post of **Assistant Engineer (Trans)** of the candidates who had appeared for the on-line test conducted on 01.06.2016 is **scheduled on 17.03.2017**. Other details, such as Reporting Time, Venue, Center, Instructions, etc. are given in the online test call letter.

4. **Links for downloading** on-line test Call Letter & On-line Mock Test, guidelines for persons with disabilities candidates using scribe, information handout and alfa order list of candidates called for re-examination (on-line-test) are given at the end of this notification. Candidates who had appeared for the on-line tests conducted on 01.06.2016 are requested to download their call letter and read it carefully before appearing for re-examination. For downloading of call letter, candidates required to click on the link given at the end of this notification and enter their Registration Number and Password in the space **“Existing User Login Here For Admit Card”** caption. Also, copy of Call Letter being forwarded on registered email id of candidates.

5. In case of any difficulty in downloading call letter, candidates may contact at **022-42040240, 022-42040188, 022-26595212, 022-26595216, 022-26595228 & 022- 26595278**. Candidate may also write an e-mail to [callletter\\_helpdesk@mahatransco.in](mailto:callletter_helpdesk@mahatransco.in). The said e-mail ID shall remain active till 15.03.2017 (up to 14.00 hours)

6. Only, the candidates who had appeared for the on-line test conducted on 01.06.2016 have been called for re-examination (on-line test) without verifying their eligibility criteria viz., age, qualification, etc. Hence, before appearing for the re-examination (on-line test), candidates must ensure that they fulfill the eligibility criteria in all respects as stipulated in advertisement vide No.02/2016 published by the Company.

**Instructions for appearing Re-examination (On-line Test):-**

8. Candidates are informed to bring hard copy/print out of call letter alongwith **currently valid Photo identity proof (as mentioned below) in original and a photocopy** of the same ID proof, which is essential. The call-letter alongwith photocopy of photo identity proof duly stapled together is required to handover to the invigilator before starting of on-line test. **Candidate’s name as appearing on the call letter shall exactly match with the name as appearing on the photo identity proof.**

9. The currently valid photo identity proof may be 'PAN Card/ Passport/ Driving License/ Voter's Card/ Bank Passbook with photograph/ Photo Identity Proof issued by a Gazetted Officer on official letterhead/ Photo Identity Proof issued by a People's Representative on official letterhead/ valid recent Identity Card issued by a recognized college/ university/ Aadhar card with a photograph/ Employee ID/ Bar Council Identity card with photograph'

10. **IDENTITY VERIFICATION:- In the examination hall, the call letter along with a photocopy of the candidate's photo identity (as mentioned in 8 above) should be submitted to the invigilator for verification.** The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the re-examination (on-line test).

11. **For Female candidates:-** Their names as appearing on the Call Letter (provided by them during the process of registration) should exactly match with the name as appearing on the Photo Identity Proof. **Female candidates who have changed first / middle / last name post marriage must take special note of this.** If there is any mismatch between the name indicated in the Call Letter & Photo Identity Proof that female candidates will not be allowed to appear for on-line test.

12. Candidates should report at examination Centre as per the reporting time mentioned in the Call Letters. Candidates reporting late for whatsoever reason i.e. **after the reporting time specified on the call letter for re-examination** (on-line test), **will not be permitted to appear for the re-examination** (online test).

13. Candidates will have to appear for re-examination (on-line test) at Examination Centre at their own risks and MAHATRANSCO will not be responsible for any injury or losses, etc of any nature.

14. The Company reserves right to allot the candidates to any center other than the center he / she has opted for, for any reason. The decision of the Company in this regard shall be final. Request for change in the exam centre will not be entertained.
