- 2.1 Pre-requisites are minimum and mere possession of the same does not entitle the candidate to be called for Selection process. The candidates will be short-listed commensurate with the number of vacancies.
- 2.2 The posts advertised are of senior level. Therefore, the experience at the level of Senior positions/Pay Group –I/Class-I is desired.
- 3. <u>Age Limit as on 12.08.2009</u>: 48 years.
- 3.1 Upper age limit is relaxable by 5 years for the candidates belonging to backward classes (Upper age limit is not applicable to the departmental employees working in the Company).
- 3.2 Date of birth as per Secondary School Certificate (SSC) and age as on 12.08.2009 should be mentioned in the application.

- 4.1 Pay scales are due for revision w.e.f. April, 2008
- 4.2 The selected candidates are entitled to DA, HRA, Medical benefit, Leave Encashment, CPF, and Gratuity etc. as per Company's rules.

5. Reservation

- 5.1 There shall be 30% horizontal reservation for women as per the provisions of Govt. of Maharashtra Resolution No.82/2001/MSA-2000/PK 415/K2 dt. 25.05.2001. The Open category women candidates who wish to avail benefit of women reservation should submit certificate from the appropriate Competent Authority showing they do not belong to "Creamy Layer" category.
- 5.2 The reservation for Women is Horizontal reservation and candidates selected against the quota for Women will be placed in appropriate category viz, SC, ST & Open categories depending upon the category to which they belong in the roster meant for reservation of the Backward classes.
- 5.3 Maharashtra State Public Services (Reservation for Scheduled Castes, Schedule Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward category and other Backward Classes) Act.2001 has been enforced by the Govt. of Maharashtra from 29th, January, 2004. As per the provisions under sub-station 2 (ii) of Section-4 of this Act, the principle of Creamy-Layer has been made applicable to all categories except Schedule Castes and Scheduled Tribes. The candidates should produce a caste certificate from appropriate authority as prescribed by the Govt. of Maharashtra vide Circular No. CBC-10/2006/PK 15/BCR5 dated 5/6/2006, showing that they are not covered under the concept of "Creamy Layer"
- The candidates belonging to ST category applying without validity certificate of caste claim, if selected, will be appointed only after submission of caste validity certificate issued by appropriate authorities as per G.R.No.STC-1099/F No.14/K-10 dated 16/8/2000 and as Energy Department Govt. of Maharashtra letter No.ESTT-2007/P.K.21/NRG-2 dated 16/8/2007.
- As per Government Resolution No.CBC-10/2003/PK91/BCR-5 dt. 8.12.2003, the candidates for claiming the benefit of reservation under SC, ST, VJA, NTB, NTC, NTD, Spl.BC & OBC categories, they should produce a caste certificate alongwith <u>caste validity certificate</u> issued by Caste Scrutiny Committee. However, as per Govt. Resolution No.CBC-10/2003/PK91/BCR-5 dt. 28.01.2004 read with Govt. Resolution CBC-10/2003/PK91/BCR-5 dt. 04.02.2004 the candidates applying without validity certificate will be given appointment (except ST Candidates) subject to production of Caste Validity Certificate within the period of 3 months.
- 5.6 For claiming the benefit of caste reservation, candidates should attach attested copy of caste certificate issued by the appropriate Authority of Govt. of Maharashtra alongwith application
- 5.7 For claiming the benefit of reservation under Backward Class category, the candidates should produce a caste validity certificate issued by Caste Scrutiny Committee. The candidates applying without validity certificates of caste claim, if selected, will be appointment unless their validity certificates are received within the validity period of select list i.e. within one year from the date of display of the Select list.
- 5.8 Those reserved category candidates who compete with the Open category candidates will be treated as Open category candidate for the purpose of recruitment/selection process.

- 5.9 The caste certificate issued by appropriate Competent Authority of Maharashtra State only will be considered as valid for availing the benefit of reservation.
- 5.10 Applications are invited for the reserved vacancies from the candidates who are fulfilling the following conditions:-
- 5.10(i) Candidate should be domicile of Maharashtra State.
- 5.10(ii) Candidate should be of categories notified for the Maharashtra State viz (a) Scheduled castes (including SC category person who has adopted Buddha Religion) (b) Schedule Tribes.
- 5.11 Once the caste is notified in application form, it cannot be changed at any stage later on.
- 5.12 The Backward Class candidates who apply against Open category will not be permitted to change the option once exercised at any stage later on.

6. Methodology of Selection:

- 6.1 The candidates will be shortlisted for selection process taking into consideration the qualification, experience, etc,
- 6.2 The selection process will consist of In-Basket Exercises, Group Discussion Exercises, Committee Exercises, Personal interview etc.
- 6.3 The candidates will be shortlisted for personal interview taking into consideration their performance in the In-Basket Exercises, Group Discussion Exercises, & Committee Exercises etc.
- 6.4 The list of applicants shortlisted for selection process will be made available on the website of the Company. Similarly the list of finally selected candidates will also be displayed on the website.
- 6.5 The recruitment in MSETCL is done strictly as per merit in a systematic way giving appropriate weightage to various selection tools.
- 6.6 Canvassing in any form will disqualify a candidate.
- 6.7 If any false/incorrect information furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered.
- 6.8 If the candidate knowingly or willfully furnishes incorrect or false particulars or suppresses material information he/she will be disqualified and if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.

- 6.9 The decision of the Company in all matters relating to recruitment shall be final and no individual correspondence will be entertained.
- 6.10 The selection of Departmental candidate will be subject to verification of disciplinary actions and vigilance enquiries in process/contemplated and other service records. The decision of the Company in this regard shall be final and no individual representation will be entertained.

7.2 The Company reserves the right to cancel the Advertisement fully or partly on any grounds and such decision of the Company will not be notified or intimated to the candidates.

8. Application Fee:

- 8.1 Candidates belonging to Open category shall furnish Demand Draft/Pay Order of the value of Rs.600/- and candidates from Backward Class categories i.e. SC, ST shall furnish Demand Draft/ Pay Order of Rs.300/- payable to the "Maharashtra State Electricity Transmission Company Ltd., Mumbai" drawn on any Nationalised Bank payable at Mumbai. The Demand Draft / Pay Order should have six months validity period.
- 8.2 The candidate should write his Full name, Caste & Post applied on the backside of Demand Draft/ Pay Order.
- 8.3 Fees in the form of Postal order/Money Order/Cheque or any other form other than DD/ Pay Order will not be accepted.
- 8.4 In case selection process could not be conducted for any reason, the fees paid will not be refunded.

9. Procedure to apply:

- 9.1 Candidates applying for the posts advertised should ensure that they fulfill all eligibility criteria. Their admission to all the stages of the recruitment process will be purely provisional subject to satisfying the prescribed eligibility criteria mentioned in this Advertisement. The Company will take up verification of eligibility conditions with reference to documents submitted by the candidate only after the candidate has qualified for interview.
- 9.2 This advertisement is published subject to the provisions of Maharashtra Civil Services (declaration of Small Family) Rules, 2005, prescribing declaration of the small family as one of the essential qualifications.
- 9.3 Knowledge of "Marathi" is desirable. However, if selected, the candidates not possessing the knowledge of Marathi will have to pass Departmental Marathi Language Examination within stipulated period of three years from the date of joining the Company.
- 9.4 Employees working in Govt./Semi.Govt. Undertaking will have to produce No Objection Certificate at the time of interview.

- 9.5 The application must be submitted in the Proforma given in this advertisement/website in the same order preferably typewritten on fullscape paper. All items of the application must be filled in according to instructions given for filling the application form.
