He shall submit the forest proposal online as per the requirement of Forest Department. He will assist to route the proposal through various authorities viz. RFO-DFO-CCF-PCCF-Nodal Officer-State Government and finally to get the NOC from MoEF, Delhi or Forest Authority, Bhopal. He will regularly monitor the status of forest proposal at all the levels so as to speed up the proposal process.
