

# RESULT OF THE RECRUITMENT FOR THE POST OF MANAGER (F&A), DY. MANAGER (F&A), ASSTT. MANAGER (F&A) & JR. MANAGER (F&A) ADVERTISED VIDE ADVT. NO. 01/2012 & SUPPLEMENTARY ADVT. TO ADVT. NO. 01/2012.

- An advertisement for filling in the various posts was published in the month of June/July, 2012. The Written Test was conducted on 19.08.2012 and 09.09.2012. Personal interviews were also held on 27.11.2012 at Mumbai.
- 2) The category-wise list of select & waiting list of candidates for the post of Manager (F&A), Dy. Manager (F&A), Asstt. Manager (F&A) & Jr. Manager (F&A) is drawn.
- While drawing select list, out of 150 marks obtained in Written Test have been converted into 90 marks and out of 50 marks obtained in personal interview have been converted into 10 marks. Thus merit list has been drawn out of 100 marks.
- 4) The select list is drawn in order of merit by adding interview marks to the Written Test marks of qualified candidates on the basis of aggregate vis-à-vis vacancies advertised and anticipated during the year.
- 5) The reservation for the physically handicapped persons and women has been considered.
- 6) Selection of female candidates (other than SC & ST) against Women reservation is subject to production of Latest/Current Year non-creamy layer certificate and Maharashtra Domicile Certificate issued by the Competent Authority of Govt. of Maharashtra.
- 7) Selection of Backward Class Candidates (other than SC & ST) is subject to production of Latest/current year Non-Creamy Layer Certificate issued by the Competent Authority of Govt. of Maharashtra.
- 8) The candidates selected against Reservation will have to produce Cast Validity Certificate as per directives prescribed in GR of Government of Maharashtra vide No. बीसीसी-२०११/प्र.क्र.१०६४/२०११/१६-ब दि. १२.१२.२०११.
- 9) If any departmental reserved category candidate who have entered in MSEB / MSETCL by availing the benefit of reservation earlier, he/she will have to submit the caste certificate & caste validity certificate issued by the Competent Authority before appointment, even though he/she is selected by applying under Open Category in this advertisement.
- 10) The select list will not confer any right on the candidates for immediate appointment, as the select list is prepared considering the vacancies arising in the year 2013. As such, the appointment letters will be issued taking into account availability of vacancies, reservation for backward classes etc.
- In case of departmental candidates, their appointment shall be subject to verification of disciplinary action / vigilance report, if any.
- 12) The selection of the candidates is purely on provisional basis subject to conforming of the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, his/her selection is liable to be cancelled at any stage, even if appointed his/her services are liable for termination.
