



Interview Schedule for the various posts of HR and V&S Cadre against Advt. No. 3/2010 of MSETCL

The written test for the various posts of HR and V&S Cadre (advertised vide Advt. No. 3/2010) was held on 28.11.2010. Taking into consideration the performance in the written test, the candidates have been short listed for personal interview.

The call letters for personal interview to the short listed candidates have already been dispatched by Post. In case any shortlisted candidate whose name is indicated in the list given below does not receive the call letter for personal interview, he is advised to report at the above venue alongwith identity proof and counterfoil of the call letter in token of having appeared for written test.

Instructions to the Candidates:

1. Candidate should bring all original Certificates regarding Educational Qualifications (i.e. degree & statement of marks), Experience, Age, S.S.C. Certificate & Caste Certificate, Non-Creamy Layer Certificate, Caste validity certificate, etc., whatever applicable together with one set of attested/true copy of each of these certificates at the time of interview.
2. Candidate belonging to Backward class category other than SC & ST, should produce a Certificate from appropriate authority as prescribed by Govt. of Maharashtra vide Circular No. CBC-10/ 2006/PK 15/ BCR-5 dated 5/6/2006 showing that candidate is not covered under Concept of Creamy Layer.
3. *The unemployed reserved category candidates namely SC, ST, VJ(A), NT(B), NT(C), NT(D) & Spl. BC will be given reimbursement of traveling expenses equal to the second class rail fare (without reservation charges) or ordinary S.T. bus fare from the place of their residence to the place of Interview and back (limited to journey performed within the State of Maharashtra) on production of original/Xerox copy of the Rail/S.T. bus fare tickets alongwith copy of caste certificate/non-Creamy Layer Certificate wherever applicable issued by the appropriate Competent Authority, as per Govt. rules as amended from time to time. However, local journey charges shall not be reimbursed.*

4. Your candidature shall stand cancelled and you will not be allowed to appear for the personal interview, unless you produce all the required documents. **Candidates appearing for interview should ensure and satisfy all the conditions including QUALIFICATION & EXPERIENCE as notified in the Advertisement.**

5. **At the time of interview the candidate should comply with the queries/deficiencies, if any, communicated to him in the interview call letter failing which he will not be allowed to appear for interview.**

6. Any request for change of time, date and/or venue of the interview will not be entertained under any circumstances.

7. If the interviews are not completed on the aforesaid date, the same will be continued/held on the next day. Therefore, you are requested to come duly prepared for the same at your own cost.

8. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to their selection/recruitment for the above post shall be considered as **DISQUALIFICATION**.

9. No query/correspondence on this issue will be entertained.

10. The call letter for the interview is purely provisional and does not confer any automatic right of your possible employment with the Company. If, at any stage, information provided by you is found incorrect/incomplete or is not in conformity with eligibility criteria as specified in the advertisement for the above post or if it is found that you have concealed/ distorted any material information, your candidature will be cancelled at any time during the recruitment process.
