

**Notification Regarding Advt. No. 02/2016**

**Extension of last date for submission of online application  
for the Technical Posts  
and  
Clarification regarding Sports Persons Reservation**

- A. Extension of last date for submission**:- Advertisement No. 02/2016 for filling in various technical posts viz: Deputy Executive Engineer (Civil), Assistant Engineer (Trans), Assistant Engineer (Telecom) and Assistant Engineer (Civil) is issued on 02.03.2016. As mentioned in the advertisement last date of submission of on-line application alongwith uploading of documents is 22.03.2016. Meanwhile Company's website i.e. [www.mahatransco.in](http://www.mahatransco.in) was not properly working / available for some period to the candidates for submission of online applications alongwith uploading the required documents. Considering this fact, **it has been decided to extend the last date of submission of online application along with uploading of required documents till 31.03.2016 (till 23.59 hrs.)** However, other contents/conditions including cut-off date for considering pre-requisites as mentioned in the advertisement shall remain unchanged.
- B. Revised condition regarding Sports Persons Reservation as mentioned at Sr.No.5(ii)**:-

<p>There shall be 5% horizontal reservation for <b>Sports Persons of Maharashtra State</b> as per the provision of Govt. of Maharashtra Resolution No. Rajya Krida Dhoran-2002/No. 68/KRI.U.SE-2 dated 30.04.2005 issued by Department of School Education and Sports, Govt. of Maharashtra. The candidates who desire to avail benefit of reservation for Sports Person <b>should upload relevant sports certificate</b> issued by Competent Authority as stipulated in the Govt. Resolution mentioned above. Further, as per the prevailing directives of Govt. of Maharashtra, all such candidates should also <b>required to upload Non Creamy Layer Certificate</b> in the prescribed format issued by the appropriate Competent Authority of Govt. of Maharashtra valid on the last date of submission of on-line application form i.e. <b>22.03.2016</b>. He/she should also upload <b>Domicile certificate of Maharashtra State</b> issued by the appropriate Authority of Govt. of Maharashtra.</p>	<p>There shall be 5% horizontal reservation for <b>Sports Persons of Maharashtra State</b> as per the provision of Govt. of Maharashtra Resolution No. Rajya Krida Dhoran-2002/No. 68/KRI.U.SE-2 dated 30.04.2005 read with vide GR No. संक्रीआ-२०१०/(प्र.क्र.२७०/१०) क्रीयुसे-२, दि.१७.०८.२०१० issued by Department of School Education and Sports, Govt. of Maharashtra.
