

POSTS OF HR, F&A AND V&S CADRES ADVERTISED VIDE ADVT. NO. 02/2014

- 1. An advertisement for filling in the various posts was published in the month of January 2014. The Written Test was conducted in the month of March 2014. Personal Interviews were also held from 10.11.2014 to 19.11.2014 at Mumbai.
- 2. The category-wise select & wait list of posts in HR, F&A & Vigilance & Security cadre is drawn.
- 3. Post-wise details of candidate not found suitable / qualified / filled is shown below:
 - a) For the post of Assistant General Manager (F&A) no application is received from ST & SBC category.
 - b) Due to inadequate response for the post of Assistant General Manager (HR), it has been decided to re-advertised the post.
 - c) For the post of Senior Manager (F&A) and Manager (F&A), no application is received from ST & VJ(A) Category.
 - d) No suitable candidate found for the post of Deputy Chief Security Officer.
 - e) For the post of Junior Security Officer / Junior Vigilance Officer, candidate from VJ(A) category not appeared for the Personal Interview.
- 4. While drawing select list, out of 150 marks obtained in On-Line Written Test have been converted into 90 marks and out of 50 marks obtained in Personal Interview have been converted into 10 marks. Thus, merit list has been drawn out of 100 marks.
- 5. The select list is drawn in order of merit by adding interview marks to the On-Line Written Test marks of qualified candidates on the basis of aggregate vis-à-vis vacancies advertised.
- 6. The reserved category candidates who have been selected on merit are treated as selected against 'Open category'.
- 7. The reservation for the Physically Handicapped Persons, Sports Persons and Women has been considered.
- 8. Selection of female candidates (other than SC & ST) against Women reservation is subject to production of Latest/Current Year non-creamy layer certificate and Maharashtra Domicile Certificate issued by the Competent Authority of Govt. of Maharashtra.
- 9. Selection of Backward Class Candidates is subject to production of Maharashtra Domicile Certificate and **Latest/current year Non-Creamy Layer Certificate** (other than SC & ST) issued by the Competent Authority of Govt. of Maharashtra.
- 4. The candidates selected against Reservation will have to produce Cast Validity Certificate as per directives prescribed in GR of Government of Maharashtra vide No. बीसीसी-२०९/प्र.क्र.२९१/०९/१६-ब दि. ०५.११.२००९ read with GR No. बीसीसी-२०११/प्र.क्र.१०६४/२०११/१६-ब दि. १२.१२.२०११.
- 10. If any departmental reserved category candidate who have entered in MSEB / MSETCL by availing the benefit of reservation earlier, he/she will have to submit the caste certificate & caste validity certificate issued by the Competent Authority before appointment, even though he/she is selected by applying under Open Category in this advertisement.
- 11. The select list will not confer any right on the candidates for appointment and appointment letters / orders will be issued taking into account availability of vacancies, reservation for backward classes etc.
- 12. In case of departmental candidates, their appointment shall be subject to verification of Disciplinary Action report & Vigilance enquiry in process / contemplated, if any.

- 13. The selection of the candidate is purely on provisional basis subject to conforming of the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, or he / she has knowingly or willfully furnished incorrect or false particulars / fake certificates or suppressed material information, his / her selection is liable to be cancelled and if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.
