



## MAHARASHTRA STATE ELECTRICITY TRANSMISSION CO. LTD

### RESULTS OF THE RECRUITMENT FOR THE VARIOUS POSTS OF HR, IR AND V&S CADRE ADVERTISED VIDE ADVT. NO. 03/2010 & 04/2010

- 1) An advertisement No. 3/2010 & 4/2010 for filling in the various posts of HR, IR AND V&S Cadre was published. The Written Test was conducted on 28.11.2010 and personal interviews were held on 03.03.2011 at Mumbai.
- 2) The list of successful candidates for the various posts of HR, IR and V&S Cadre is given below. While drawing select list, revised vacancy position/ reservation position has been taken into account.
- 3) Post-wise details of candidate not found suitable / qualified is shown below:
  - a) **For the post of Assistant General Manager (HR) no candidate has been qualified from ST & VJ (A) category.**
  - b) **For the post of Sr. Manager (HR), no candidate has been qualified from NT-C Category.**
  - c) **For the post of Manager (HR) only one candidate found eligible in ST category.**
  - d) **Selection process for the post of IR/Welfare Office has been kept in abeyance.**
  - e) **No suitable candidate found for the post of Dy. Chief Security Officer.**
  - f) **For the post of Jr. Security Officer, no candidate has been qualified from VJ (A) category.**
- 4) While drawing select list, out of 150 marks obtained in Written Test (wherever written test was conducted) have been converted into 90 marks and out of 50 marks obtained in personal interview have been converted into 10 marks. Thus merit list has been drawn out of 100 marks.
- 5) The select list is drawn in order of merit by adding interview marks to the Written Test marks of qualified candidates on the basis of aggregate vis-à-vis vacancies advertised and anticipated during the year.
- 6) The reserved category candidates who have been selected on merit are treated as selected against 'open category'.
- 7) The reservation for the physically handicapped persons has been considered.
- 8) **Likewise selection of Backward Class Candidates is subject to production of Caste Validation Certificate from the Caste Scrutiny Committee, if not submitted along with application.**

9) The select list will not confer any right on the candidates for immediate appointment as the select list is meant for the entire year i.e. 2011. As such, the appointment letters will be issued taking into account availability of vacancies for direct recruitment, reservation for backward classes etc.

10) In respect of departmental candidates their appointment shall be subject to verification of disciplinary action / vigilance report, if any.

**11) The selection of the candidates is purely on provisional basis subject to conforming of the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, his selection is liable to be cancelled.**

12) While every care has been taken in preparing the results, MSETCL reserves the right to rectify any inadvertent error or typographical mistake.

13) The decision of the Company shall be final and no individual representation/correspondence will be entertained.
