

**RESULT OF THE RECRUITMENT PROCESS FOR THE POST OF
SUPERINTENDING ENGINEER (TRANS) ADVERTISED VIDE ADVT. NO. 09/2016**

- 1) Advertisements No. 09/2016 was published in the month of December-2016 for filling in the One (01) (Open) post of Superintending Engineer (Trans).
- 2) As per condition number 6 (ii) of the advertisement, the candidates who were apparently eligible as per age and educational criteria were called for first four tools of Competency Mapping Test viz., In-Basket Exercise, Group Discussion, Case Discussion and Presentation Skill without verifying their eligibility in details i.e. Experience, Experience in Power Sector, Area of Power Transmission, etc.
- 3) Taking into consideration the pre-requisites as mentioned in the advertisement and based on overall performances reflected in all four exercises viz., In-basket Exercise, Group Discussion, Case Discussion & Presentation Skill, 06 candidates were short-listed for Personal Interview. The Personal Interviews have been conducted on 30.01.2017.
