

Supplementary Advertisement to Employment Advt. No. 01/2012

(Only for Physically Handicapped Persons with disability of One Arm or One Leg)

An advertisement vide No. 01/2012 was published for filling in the various posts viz. Head System (IT), General Manager (F&A), Manager (F&A), Dy. Manager (F&A), Assistant Manager (F&A), Jr. Manager (F&A), Dy. Chief Industrial Relations Officer, JE (Trans)-Trainee. The written test was also scheduled on 19.08.2012.

- 2. However, after publishing of the above advt., it is observed that, the physically handicapped reservation in Pay Group I categories for Finance & Accounts Cadre mentioned in the Employment Advertisement No. 01/2012 for the post of General Manager (F&A), Manager (F&A), Dy. Manager (F&A) and Assistant Manager (F&A) was erroneously printed as **OAL** (<u>One Arm and One Leg)</u> instead of **OA** (<u>One Arm</u>) / <u>OL</u> (<u>One Leg)</u>. Consequently it might happened that, some of the candidates belonging to disability of OA or OL may not have applied for the said posts.
- 3. In order to give fair chance to disabled persons, it is now decided to invite the applications from <u>only</u> such candidates who are having physical disabilities of <u>One Arm or One Leg</u> for the posts indicated below in Pay Group I in Finance & Accounts Cadre as advertised vide No. 01/2012.

- 4. The candidates who have **already applied** against the **reservation of physically handicapped** in pursuance of Employment Advertisement No. 01/2012 and submitted the required documents **need not apply again.**
- 5. Since, applications are invited only from the persons having disability of One Arm or One Leg, application fee is not applicable.
- 6. As it is supplementary advertisement, the date for fulfilling the pre-requisites and age limit shall remain unchanged i.e. 18.07.2012.
- 7. The last date of submission of on-line application is 31.08.2012 and the tentative date of written test is 09.09.2012 for the post code No. 03, 04 & 05. The selection process for the post code No. 02 shall be intimated separately.

8. **Important Note:-**

Only the candidates with Disability of **One Arm or One Leg** (<u>ONLY</u>) shall apply for above posts. Persons suffering from not less than 40% of disability of One Arm or One Leg shall only be eligible for the benefit of reservation for Persons with Disability. The candidate should submit copy of Medical certificate issued by the appropriate Medical Board in terms of Govt. of India, Office Memorandum No. 36035/3/2004- Estt (Res.) dated 29.12.2005.

- 9. Print out of on-line application alongwith the attested copies of certificates in support of Age, Qualification and medical certificate issued by the Appropriate Authority showing disability not less than 40%, Experience, Caste, Caste Validity, Non Creamy Layer & Domicile etc. whichever is applicable should be sent to Post Box NO 8451, Mandpeshwar Post Office, Borivali (West), Mumbai 400103 so as to reach on or before 10.09.2012.
- 10. Other terms and conditions mentioned in the advertisement No. 01/2012 shall remain unchanged. The candidates are requested to refer the original advertisement before applying which is kept below for information.
