

**Refund of Examination Fee againsts
Advertisements published in Recruitment Year 2023-2024**

**Read: (1) Notification dtd. 23.08.2024 } regarding refund of
(2) Notification dtd. 30.08.2024 } Examination Fees**

In order to implement Socially and Economically Backward Classes (SEBC) Reservation, the Advertisements of various posts issued during the period 2023-2024 have been re-advertised after implementing SEBC Reservation.

2. For that matter candidates were asked to submit fresh application alongwith Examination Fees for the re-advertised posts. It was directed to the candidate that their Examination Fees paid for the earlier advertised posts (without implementation of SEBC Reservation) will be refunded to their respective Bank Account.

3. The Company accordingly directed the third party Recruitment Agency to carry out “Same Channel Refund” of the Examination Fees to the candidate’s Bank Account. However, due to technical constraint, the Same Channel Refund could be carried out in respect of few candidates by the third party Recruitment Agency. The third party Recruitment Agency also reported that the data base of the Bank details of the candidates are not stored due to security constraint.

4. Therefore, in order to complete the work of refund of the Examination Fees, the Company had given first call of Notice vide its Notification dtd. 23.08.2024 for obtaining the Bank details of the candidates giving time upto 30.08.2024.

5. It is come to the notice that all candidates could not submit their Bank details in this period. Therefore, considering their request to extend the date for submission of bank details, the Company had given second call of notice vide Notification dtd. 30.08.2024 for obtaining Bank details of the candidates giving time upto 15.09.2024.

6. Out of total count after executing Same Channel Refund of 82,781 candidates, only 46,687 candidates have submitted their Bank details through link (Google Form) till 15.09.2024. Out of which, the bank could process 26,965 refund entries and rejected 19,722 entries for reasons like wrong IFSC Code, mismatch of IFSC Code etc.

8. The candidates who have not submitted bank details yet and whoes refund has been rejected by bank for wrong entries, a last and final opportunity is given to submit their Bank details in link given below (Google Form) before 25.10.2024 to enable refund of Examination Fee. No other mode of submission of Bank Details shall be considered.

9. It may be noted that, if the candidates do not submit their bank details or submit wrong bank details, the Examination Fee will not be refunded and it will be deposited in the Company’s No Claim Deposit Account.

10. Therefore, the candidates are requested to submit their bank details carefully and correctly through following link (Google Form) to enable refund of Examination Fees before 25.10.2024.
