- e) Domicile Certificate (If applied against reservation)
- f) Caste Validity (If available If applied against reserve category post)
- g) Valid Non-Creamy Layer Certificate. {If applied against reserve category post (Except SC & ST) }
- h) Medical / PWD Certificate (If applied against PWD reservation)
- i) Certificate regarding physical limitation in an examinee to write (if availed Compensatory Time in On-line Test)
- j) Sports Certificate (If applied against Sports reservation)
- k) Orphan Certificate (If applied against Orphan reservation)

- Economically Weaker Section Eligibility Certificate (If applied against EWS reservation)
- m) Marathi Language Certificate (As mentioned in the advertisement)
- n) Change of Name certificate (If applicable)
- o) Experience Certificate
- p) No Objection Certificate from the employer (If working in Government / Semi Government Undertaking)
