- 2.1 Pre-requisites are minimum and mere possession of the same does not entitle the candidate to be called for Selection process. The candidates will be short-listed commensurate with the number of vacancies.
- 2.2 The posts advertised are of senior level. Therefore, the experience at the level of Senior positions/Pay Group –I/Class-I is desired.

Age Limit : Upper age limit upto 45 years.

Note :

- 1) The qualification, experience and upper age limit should be as on **15.12.2009**
- 2) Upper age limit is not applicable to the Departmental Employees working in the Company (Only in MSETCL)

- 2.3 The selected candidate will be entitled to DA, HRA, Medical benefit, Leave Encashment, CPF, and Gratuity etc. as per Company's rules.
- 2.4 Candidate should be domicile of Maharashtra State.
- 2.5 Once the caste is notified in application form, it cannot be changed at any stage later on.

3. Methodology of Selection:

- 3.1 The candidates will be shortlisted for selection process taking into consideration the qualification, experience, etc,
- 3.2 The selection process will consist of In-Basket Exercises, Group Discussion Exercises, Committee Exercises, Personal interview etc.
- 3.3 The candidates will be shortlisted for personal interview taking into consideration their performance in the In-Basket Exercises, Group Discussion Exercises, & Committee Exercises etc.
- 3.4 The list of applicants shortlisted for selection process will be made available on the website of the Company. Similarly the list of finally selected candidates will also be displayed on the website.
- 3.5 The recruitment in MSETCL is done strictly as per merit in a systematic way giving appropriate weightage to various selection tools.
- 3.6 Canvassing in any form will disqualify a candidate.
- 3.7 If any false/incorrect information furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered.
- 3.8 If the candidate knowingly or willfully furnishes incorrect or false particulars or suppresses material information he/she will be disqualified and if appointed, shall be liable for dismissal from the Company's service without any notice or assigning any reasons whatsoever.

- 5.3 Fees in the form of Postal order/Money Order/Cheque or any other form other than DD/ Pay Order will not be accepted.
- 5.4 In case selection process could not be conducted for any reason, the fees paid will not be refunded.

6. **Procedure to apply:**

- 6.1 Candidates applying for the posts advertised should ensure that they fulfill all eligibility criteria. Their admission to all the stages of the recruitment process will be purely provisional subject to satisfying the prescribed eligibility criteria mentioned in this Advertisement. The Company will take up verification of eligibility conditions with reference to documents submitted by the candidate only after the candidate has qualified for interview.
- 6.2 This advertisement is published subject to the provisions of Maharashtra Civil Services (declaration of Small Family) Rules, 2005, prescribing declaration of the small family as one of the essential qualifications.
