We at MAHATRANSCO, one of the largest Transmission Utilities in the State operating about 36,000 CKT KM transmission lines and 498 EHV Sub-stations and having transformation capacity of 56564 MVA invites applications from the Retired District and Session Judges for the post of *Chief Legal Advisor* on Contract Basis.

1. **Pre-requisites and other conditions:**

Qualification: Should have worked in the capacity of District & Session Judge at least for a period of 3 years.

Upper age limit: Should not be more than 62 years of age.

Period of Contract: The period of contract will be of three years **OR** till attaining the age of 65 years, whichever is earlier.

Pay scales and perquisites: The selected candidate will get emoluments in the pay scale of Rs.28700-1235-34875-1365-63450. The gross emolument would be about Rs.41856/(without accommodation). Besides, the candidate would be entitled to other facilities like car, cell phone etc. for official use. The accommodation can be provided, if available. In case accommodation is provided, HRA would not be paid and license fee as per rules will be deducted.

- 5.1 The details of interview schedule will be communicated to the short listed candidates by e-mail, telephonically. The call letter for personal interview will not be sent.
- 5.2 The list of applicants short listed for selection process will be made available on the website of the Company. Similarly, the list of finally selected candidates will also be displayed on the website.
- 5.3 The short listed candidates will have to appear for the Personal Interview at their own cost. Traveling expenses will not be reimbursed.
- 5.4 The recruitment in MSETCL is done strictly as per merit in a systematic way.
- 5.5 Canvassing in any form will disqualify a candidate.
- 5.6 If any false/incorrect information furnished by the candidate is detected at any state of recruitment process; his/hr candidate will not be considered.
