1. **Pre-requisites and other conditions :**

Qualifications:

<u>Essential</u> - Graduate with Associate Membership of the Institute

Secretaries of India (ACS).

- Computer Literacy

<u>Preferable</u> - Degree in Law from a recognized university.

Experience: Candidate should have minimum 5 years post qualification experience as Company Secretary/Asstt. Company Secretary.

Upper age limit: Should not be more than 53 years of age.

Period of Contract: The period of contract will be initially for a period of five years and will be considered for extension based on performance.

Pay scale and Perquisites: The selected candidate will get emoluments in the pay scale of Rs.36720-1560-71040. At present, the gross emoluments is Rs.65,650/- p.m. (without accommodation).
