## Interview Schedule for the various posts of F & A Cadre vide Advt.No.8/2009 of MSETCL

The call letters for personal interview to the short listed candidates have already been dispatched by Post Under Certificate of Posting. In case any shortlisted candidate does not receive the call letter for personal interview, he is advised to report at the venue alongwith identity proof and counterfoil of the call letter in token of having appeared for written test.

## **Instructions To the Candidates:**

- 1. You should bring with you the call letter along with all Original Certificates regarding your Educational Qualifications, Age, Caste, Caste Validity Certificate, Non-Creamy Layer Certificate, SSC certificate and Domicile Certificate wherever applicable together with one attested true copy of each of these certificates at the time of interview.
- 2. As per the Govt. Circular No. CBC-10/2004/PK570/BCR-5 dated05/03/2005, those candidates belonging to SC, ST, VJ(A), NT(B), NT(C), NT(D), Spl.BC & OBC will have to submit the Caste Validity Certificate.
- 3. If you belong to Backward Class other than SC & ST community, you should produce latest Non-Creamy Layer Certificate from appropriate authority as prescribed by Govt. of Maharashtra showing that you are

not covered under Concept of Creamy Layer. The selection of candidates belonging to VJ-A, NTC, NT-D and SBC shall be subject to submission of latest Non-Creamy Layer Certificate from appropriate authority as prescribed by the Govt. of Maharashtra showing that they are not covered under the concept of "Creamy Layer" on notification of rules / Orders for actual implementation of the said provision of the Act by the Govt. of Maharashtra. The Female candidates who have applied against women reservation and belonging to 'Open' category will have produce latest Non-Creamy Layer Certificate from appropriate authority showing that they are not covered under the concept of "Creamy Layer".

- 4. The unemployed reserved category candidates such as SC, ST, VJ (A), NT(C), NT(D) & Spl. BC [principle of Non-Creamy Layer is applicable for VJ(A), NT(C), NT(D) & Spl. BC categories] will be given reimbursement of traveling expenses equal to the ordinary second class rail fare or ordinary ST Bus fare from the place of their residence to the place of interview and back (limited to journey performed within the State of Maharashtra) on production of original / Xerox copy of the Rail / ST Bus fare tickets along with copy of Caste Certificate and Non-Creamy Layer Certificate (wherever applicable) issued by the appropriate Competent Authority, as per Company rules as

- 5. Any request for change of time, date and / or venue of the interview will not be entertained under any circumstances.
- 6. If the interviews are not completed on the aforesaid date, the same will be continued / held on the next day. You are, therefore, requested to come duly prepared for the same at your own cost.
- 7. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to their selection / recruitment shall be considered as DISQUALIFICATION.
- 8. Your candidature shall stand cancelled and you will not be allowed to appear for the personal interview, unless you produce all the required documents for the post. Candidates appearing for interview should ensure that they satisfy all the conditions as notified in the advertisement.
- 9. No query / correspondence will be entertained.
- 10. The interview is purely provisional and does not confer any automatic right of your possible employment with the Company. If, at any state,

- information provided by you is found incorrect / incomplete or is not in conformity with eligibility criteria or if it is found that you have concealed / distorted any material information, your candidature will be cancelled at any time during the recruitment process.
