

**RESULT OF THE RECRUITMENT PROCESS OF
ASSISTANT LAW OFFICER (ON CONTRACT BASIS)
ADVERTISED VIDE ADVT. NO. 03/2018**

1. An advertisement No. 03/2018 was published on 19.09.2018 for filing in Two post of Assistant Law Officer (on contract basis) (01-OPEN and 01-SC). Subsequently, the notification for calling eligible applicants for Personal Interview was published on Company's website on 05.11.2018. It was categorically mentioned in the said notification that :

"the post of ALO reserved for SC category will be filed in subject to approval by the Board of Directors. If such approval not accorded by the Board of Directors of MSETCL, the process of recruitment at any stage shall be withdrawn for SC category candidates, which may be noted and no representation/grievance shall be entertained in this regard. This aspect may please be considered by the candidate before appearing for the interview."

2. Accordingly, the personal interview for selection to the post of Assistant Law Officer was held on 19.11.2018 and 20.11.2018 at Corporate Office, Mumbai.
3. The marks obtained by all the appeared candidates in Personal Interview is given (List as per Notification dated 05.11.2018) in the link, at the end of notification.
4. As per advertisement, one vacancy of SC Category was published subject to approval by the Board of Directors. However, the Board of Directors of MSETCL has deferred the proposal of sanction of one additional post of ALO. Hence, the post of ALO which was earmarked for SC category in advertisement could not be filled in.
5. Accordingly, out of 02 vacancies published in advertisement, only 01 vacancy of OPEN Category could be filled in at this stage.
6. Based on the vacancy available and overall performance reflected in the personal interview following candidate is selected and waitlisted for the post of **Assistant Law Officer (on Contract Basis)** in the pay scale of **24765-975-29640-1060-55080** in order of merit.
