- 4. The following documents should be submitted along with the offer
- a) Valid Shop Act License b)Pan Card c)RTO vehicle Registration, d)Valid Tourist Permit e) Valid Insurance f)Valid PUC certificate g) Driver licensee Xerox h) Fitness Certificate i) Road Tax paid receipt recent year
- 5. Mandatory Terms & Conditions
  - a) The minimum of 1300 Km/ month will have to be borne by vendor including (Hiring Charges +Fuel +Driver ) in rate quoted at sr. no. 1 in Schedule 'A' above.

- b) The Km run above 1300km in month will be considered as extra Km and charges will be paid accordingly as per sr. no. 2 in Schedule 'A' above.
- c) The vehicle must comply with working A/C at all times during duty Hrs.
- d) The major/minor repairs & drivers expenditure will be borne by the owner. Also the Consumable/ wearable items such as wind shield wipers/tyres/break pads must be maintained.
