TERMS AND CONDITIONS OF CONTRACT

1) SIGNING OF CONTRACT:

Within 7 days from the date of the receipt of this work order, the contractor shall enter into an agreement with the Company, in the prescribed format. Until the agreement is executed, the company will not be liable to pay, nor shall the contractor be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the contractor.

2) SCOPE OF WORKS:

The scope of works includes providing of one no. of unskilled manpower as Peon for Office Work at PAC Division office, Karad.

The scope of works of Peon includes providing the services of prospective candidates for PAC Dn office, Karad. All Tech. section / HR work of PAC Dn, office. Karad. The candidates shall work as per the directions, and guidance of the respective.

4) SECURITY DEPOSIT:
