- 2. The envelope should be super scribed as "QUOTATION FOR SUPPLY OF SAFETY SHOES UNDER PAC DIVISION KOLHAPUR".
- 3. **QUOTED RATES:** The taxes applicable if any should be quoted separatly.
- 4. **Delivery Period:** Material should be delivered within 15 days from the date of the issue of order at MSETCL Executive Engineer, PAC Division, Bapat Camp, Kolhapur. Three days will be reckoned for transit. The condition for delivery should be mentioned specifically otherwise, it will be presumed that you will supply the material within stipulated time.
- 5. **Quality of Supply:** The material should be supplied as per specifications mentioned in Schedule 'A'. and guaranteed for 12 months from date of supply. Also to note size of material supplied may vary & material should be supplied as per actual required size & sample approved.
- 6. **VALIDITY OF OFFER**: The offer should be valid for our acceptance for a period of 90 days from the due date of opening.
- 7. **SECURITY DEPOSIT**: 10% of the value of order is to be paid as Security Deposit by Cash / D.D./BG in this office within 7 days from the date of intimation by this office. No. Interest will be paid on this amount and this will be refunded after completion of contract period satisfactorily & NOC from the concerned In-charge.
- 8. **Risk Purchase:** In case of failure to execute the order, the same will be purchased from other agency at our description and difference in cost will be recovered from the tenderer in addition to forfeiture of S.D.
- 9. Quantity as per schedule A & Quality as per sample approved.
- 10. **INCOME TAX:** As per govt. rule Income tax at source will be recovered from your bill as per rules. Your Income tax No. may be informed to this office.
