- 1) <u>QUOTED RATES</u> The Rates are inclusive of GST/Labour cess/Fright & Insurance.
- 2) Delivery Period: Material should be delivered within 30 days from the date of the issue of order at concern substation. Three days will be reckoned for transit. The condition for delivery should be mentioned specifically otherwise, it will be presumed that you will supply the material within stipulated time. Only any force majeure condition will be considered for late delivery
- 3) **<u>Ouality of Supply:</u>** The material should be supplied as per specifications mentioned in Schedule 'A' and from authorized MSETCL vendor. Guaranteed for supply of material shall be 12 months from date of supply. Also to note size of material supplied may vary & material should be supplied as per actual required.
- 4) <u>VALIDITY OF OFFE</u>R : The offer should be valid for our acceptance for a periof of 90 days from the due date of opening.
- 5) **SECURITY DEPOSIT** : 10% of the value of order is to be paid as Security Deposit by Cash / D.D./BG/Chq in this office within 7 days from the date of intimation by this office. No Interest will be paid on this amount and this will be refunded after completion of contract period satisfactorily & NOC from the concerned In-charge.
- 6) Risk Purchase: In case of failure to execute the order, the same will be purchased from other agency at our description and difference in cost will be recovered from the tenderer in addition to forfeiture of S.D.
- 7) Quantity & Quality as per schedule A.
