- Prices:** -Rates should be quoted item wise in percent based bid and as per schedule 'A' and for work at various S/s under EHV O&M Dn., Ratnagiri. Taxes/ duties and other levies should be quoted separately. Otherwise, it may be considered as quoted rates are inclusive of all taxes &cess.
- The work is to be completed within 15 days from handing over of equipment by the concerned officer.
- The work should be carried out as per enclosed schedule 'A' as directed by the concerned officer to the full satisfaction.
- Quantities mentioned in schedule 'A' are approximate; however, payment will be made on the basis of actual quantity of work.
- If the works is not carried out within stipulated time limit, penalty at the rate ½ % per week delay of contract value will be recovered from your bill subject to 10% maximum of order value.
- Quotations should be duly filled in all respect, otherwise it will not be considered. Guarantee period is to be mentioned in the quotation. It should be not less than 1 year.

- 8) **Security Deposit:** The contractor should pay security deposit at the rate of 5% of the value within 7 days from the date of receipt of LOI, in favor of the Superintending Engineer EHV O&M Circle Kolhapur, in the office of the Superintending Engineer EHV O&M Circle Kolhapur in form of cash/ DD of Nationalized Bank or Schedule Bank which will be refunded after completion of work successfully or completion of guarantee period & NOC from the concerned In-charge. Extension of validity of SD till over of guarantee period of work executed is sole responsibility of agency.
- 9) **Agreement Bond:** The contractor will have to execute an Indemnity Bond on stamp paper of **Rs.500/-** at his own cost within 7 days from the date of receipt of LOI.
- 10) **Workmanship:** The workmanship for this work should be of best quality.
- 11) **Income Tax etc.:** The I.T. / WCT will be deducted as per rule, your firm's Pan No., GST registration No. should be quoted on bill.

- 15) If work is not completed as per the schedule from the date of handover of site, the penalty of 1% per week subject to maximum of 10% of value of the work order will be levied & shall be deducted from your bills.
- 16) If failed to execute the work as per order in full within the stipulated period then company shall be at liberty without further notice or reminder to the contractor to get the same work done on account of and at the risk of the contractor & to prefer a claim for a difference in price & for all expenses whatsoever incurred in getting the said work and same shall be recovered from any money due to the contractor from bills or deposits on any account with any MSETCL's office. Such expenses will also include 15% supervision charges.
- 17) All disputes / differences arising under / out of or in connection with the contract shall be subject to the exclusive jurisdiction of Ratnagiri Court only.
- 18) The MSETCL Terms and conditions of work contract are applicable for this work.
- 19) Bidders have to submit an undertaking in the attached Proforma 'ANNEXURE-G' declaring that their Firm is not Debarred/Blacklisted by Govt./Semi Govt./Other Power Utilities, anywhere.
- 20) **Firm/ Bidder has to pay EMD irrespective of SRM system asks for the Same, EMD exemption is only for below mentioned conditions:**
 - 1) The Micro and small enterprise (Only manufacturing and service enterprise) as defined in MSMED Act, 2006 are exempted from paying EMD and tender fees. The Udyog Aadhar Memorandum and Udyog Aadhar Registration certificate submitted by said enterprises should indicate the same material / service as required against the tender floated.

- 2) The Bidder has to pay EMD and tender fees in following cases:
- a) If the micro/small enterprise registration certificate does not indicate the relevant classification code covering material / service as required against the tender floated.
 - b) If investment in the plant and machinery or equipment exceeds the threshold limit indicated in the MSMED Act, 2006 (at present the threshold prescribed limit being for Micro-upto Rs. 25 Lakhs small – Rs. 25 Lakhs to Rs. 5 Crs. as investment in plant and machinery and for micro –up to Rs.10 Lakhs: small Rs. 10 Lakhs to Rs. 2 Crs. as investment in equipment).
- 3) In case of works contract, if the Micro – small enterprise submits that the enterprise shall supply all the materials of intended works contract, manufactured from its own unit, then it shall be eligible for exemption of payment of EMD & tender fees to MSETCL. However, an undertaking duly notarized from micro and small Enterprise to this effect is to be submitted along with bid.
- 4) The works contractor except as stated above and Traders are excluded from the benefits of EMD and Tender fees, hence shall be required to pay EMD or Tender fees while participating for e-tender process at MSETCL.
- 5) The registration certificate as submitted by micro & small enterprise should be valid on the date of submission of bid and the validity of the same should be certified by the Chartered Accountants in practice.
- 21) The Technical bid will be opened online in respect of all SRM tender received. The commercial bid will be opened online in respect of those tenders & who are qualified in technical bid i.e. submitted all digitally signed documents/ certificate in technical bid as required in satisfactory manner.
