 - ii) An authorization letter from the manufacturer regarding dealership, preference will be given to the authorized dealer.
 - iii) Registration Certificate of the firm as per Bombay Shop Act.
 - iv) GST registration certificate.
 - v) PAN card, ITR for last 3 years.
 - vi) Make (brand name) & the detail guaranteed features of specifications along with illustrated printed catalogue of the offer.
 - vii) Order copies/Experience Certificate for similar type of works preferably in MSETCL or Government/Semi-Government/Private organizations. Order copies/Experience Certificate issued by authority not below the rank of Executive Engineer in case of Government/Semi-Government organizations will be required to be submitted.
