**Sub: - E-Enquiry** for inviting the Quotation for the work of providing crane (14 Ton & boom length 16M or as per the suitability of work), with driver, on per hour basis as and when required at 400kV Deepnagar-Bhusawal-II.

Dear Sir,

Sealed and super scribed quotations are invited for the above work as per enclosed schedule 'A'. You are requested to quote your rates for the above work. The terms and conditions are as follows.

### TERMS AND CONDITIONS

1. **Due Date:** - The quotation complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dt. 31.08.2022** up to **17:00** Hrs Positively.
2. **Order Value:** - The order value is limited to only **Rs. 2.00 Lacs** including 18% GST and 1% labor Cess.
3. **Period of Contract:-** The contract period will be for one year or till the exhaustion of Order Value which ever will be earlier.
4. **Scope of work:** - The work of providing crane (14 Ton & boom length 16M or as per the suitability of work), with driver, on per hour basis as and when required at 400kV Deepnagar-Bhusawal-II. As detailed in schedule 'A'
5. Agency should have to pay Rs. 100 against enquiry Quotation Fees by cash to this office & copy of receipt should be attached with quotation.
6. **Quoted Rates:** - The quoted rates should include the cost of taxes. The Taxes will be clearly mentioned, & if the Taxes are not clearly mention, then it will be considered as Inclusive of all taxes.
7. **Validity of Offer:** - The offer should be valid for our acceptance up to the exhausting of wok order value/contract period.
8. **Security Deposit:-** The contractor has to pay 5% of the Order value as a Security Deposit, in cash /DD/BG before commencing the service at the office of the Executive Engineer, 400kv Rs Dn. Deepnagar, Bhusawal-II within 15 days from the date of receipt of letter of intimation and same will be refunded to the contractor after successful completion of contract period.
9. **Agreement:-** The contractor has to execute the agreement as per the provision of 'Mumbai Mudrank Adhinyam 1958, Clause No. 34' with requisite stamp duty before starting of the work.
10. The crane driver provided by the contractor shall be free from any bad habits like smoking, drinking etc and should be well convergent.
11. The normal working time for the crane, on the required day, will be from 07:00 Hrs. However in case of emergencies, the crane have to spared by the contractor before or after the stipulated time as per the instructions of Executive Engineer, 400kV RS Dn, Deepnagar-BSL-II.
12. The contractor will be intimated 12 Hrs. in advance whenever the crane is required. However in case of emergencies, no prior notice can be given, and the contractor have to arrange the crane immediately whenever told by the Executive Engineer, 400kV RS Dn, Deepnagar-BSL-II.

13. The crane provided by the contractor should be provided with all necessary crane belts, its binding material etc.
14. **Document required:** - The offer rate must be accompanied with following documents duly attested & signed by vender/contractor.
  1. Proof of valid registration of firm under Bombay shop/ Gram Panchayat NOC/ Firm Registration copy/ Shop establishment Copy.
  2. Proof of Valid registration under of Goods and Service Tax Registration Certificate.
  3. Copy of PAN card
  - 4 The bidder should possess work order copies along with performance certificate issued by authority not below the Rank of Executive Engineer of similar type works as a proof of experience during last 07 years in MSETCL/other State transmission Utility/ Semi- Govt./ Govt. undertaking.
  5. Proof regarding payment of E-Enquiry Fee may please be attached.
15. The crane fuel (diesel/petrol) and lubricants to be borne by the crane provider. This office will not provide the same in any case.
16. If in case, the crane fails or stop working in the middle of the work, the contractor has to immediately provide another crane suitable for the work.
17. The necessary maintenance to be carried out and the cost of the same to be borne by the contractor only.
18. Liquidated Damages / Loss due to theft: - Any damage or loss to M. S. E T. Co. Ltd's property due to your employees' negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
19. Work should be carried out as per the directives of Addl. E.E.(Maint.) or Executive Engineer, 400kV RS Dn, Deepnagar-BSL-II.
20. Agency should submit GST Registration and other relevant registrations.
21. The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during the course of contract. Contractor will have to provide safety equipments to his employees.
22. Contractor will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The MSETCL shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.
23. The disputes, if any, shall be subjected to the jurisdiction of the Bhusawal Court only.
25. The undersigned reserves the right to cancel the E-enquiry at any stage or cancel any or all quotations without assigning any reason thereof.
26. Quarterly Bill in three copies shall be submitted to this office for payment and will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement Recorded in SES by Addl. Executive Engineer 400 kV R.S. Division, Deepnagar Bhusawal-II.
24. **Income Tax:** Income tax & GST will be deducted as per rules.
27. MSETCL bears no responsibility of any kind in r/o the worker employed for this work & Contractor shall be whole responsible to observe & follow all the statutory provisions regarding Labour laws. The rates should be quoted considering applicability of all these aspects.
28. Undersigned reserved the right to accept any quotation or to reject/ accept all the quotation without assigning any reason.

29. The workers employed by you for the above work shall not be entitled for any facility/claim from MSETCL what so ever.
30. MSETCL Reserve rights to add more terms during the contract period if found necessary.
