- 1) **<u>DUE DATE</u>**: The quotations complete in all respects should be submitted online on or before 02.09.2023@ 13:00 Hrs. positively.
- 2) <u>SCOPE OF WORK</u>: Procurement of 33KV PT for the tertiary side delta formation of 400/220kV ICT's at 400kV RS Division Khadka-Bhusawal as per Schedule "A".
- 3) Technical Specification as mention in the "Annexure-A".
- 4) **<u>QUOTED RATES</u>**: The rates quoted are including of all taxes, charges, etc.
- 5) <u>SECURITY DEPOSIT</u>: The successful bidder will have to pay an amount equivalent to 5% of Contract value towards S.D. at Executive Engineer, 400kV R Division Khadka-Bhusawal, within 15 days from the date of receipt of LOI which is refundable after satisfactorily completion of guaranty period.
- 6) <u>AGREEMENT</u>: Agreement contract between MSETCL & successful bidder should be carried out on Rs. 500/- bond paper within 15 days from the date receipt LOI. Successful bidder will have to borne the charges for agreement bond.
- 7) **VALIDITY OF OFFER:** The offer should be valid for our acceptance for a period of 180 days from the due date of this SRM E-Enquiry.
- 8) **<u>DELIVERY PERIOD</u>**: PT for the tertiary side delta formation should be delivered within 90 days from the date of work order at Major Store, Dhule.
- 9) **<u>TECHNICAL QUALIFYING CRITERIA</u>**: The rate offer must be accompanied with following documents by vendor:

<u>Technical bid (Qualifying Requirement)</u>: Bidder should upload the following digitally scan copies of original documents / certificates online in 'note & attachments' tab in RFx.

1. <u>Statutory Qualifying Requirement/Criteria:</u>

- i. The Bidder should have a valid registration under <u>Bombay shop & Establishment Act 1948/</u> <u>Small Scale Industry Act / Company (Factory) Act</u> - Proof thereof.
- ii. The Bidder should be Register under <u>Goods & Services Tax (GST) Act</u> Proof thereof.

Note: The original colored scan copy should be uploaded as bid documents in support of statutory qualifying criteria i.e. statutory licenses/registration. The attested / notarized photo copies of the same will not be entertained.

2. TECHNICAL QUALIFYING REQUIREMENT/CRITERIA:

- i. The bidder <u>either manufacturer or authorized dealer/channel partner of manufacturer</u>. If the bidder is authorized dealer/channel partner, then <u>valid authorization letter</u> from manufacturer should be uploaded for this SRM E-Enquiry.
- ii. The bidder should have in last 07 years experience of "Similar work i.e. supply of material tendered of equal or higher voltage class for amounting as follows;
- a. One completed work mentioned above having costing not less than the amount equal to 70% of the estimated amount, OR
- b. **Two** completed works mentioned above having each costing not less than the amount equal to **40%** of the estimated amount, **OR**
- c. Three completed works mentioned above having each costing not less than the amount equal to 30% of the estimated amount.
- iii. The bidder or his manufacturer should have proven experience not less than <u>5 years in</u> <u>Design, manufacture, supply, and testing of similar equipment/ material tendered</u> of equal or higher voltage class.
- iv. The Bidders or his manufacturer should have <u>adequate in-house testing facilities for</u> <u>conducting all the acceptance test</u> in accordance with relevant IS also submit valid latest type test report.
- v. The bidder should submit the end user's Certificate for <u>successful operation of material at</u> <u>least for 2 years as on the date of submission</u> issued by the authority not below the rank of Executive Engineer or Equivalent with detail work order copy.
- vi. The owner reserved the rights to accept / reject the Bid.

Note: The original colored scan copy should be uploaded as bid documents in support of Technical qualifying criteria. The attested / notarized photo copies of the same will not be entertained. Detailed communication address, e-mail ID and contact nos of the end users should be furnished for cross verification.

3. FINANCIAL QUALIFYING REQUIREMENT/CRITERIA:

i. The Average Annual turnover of the bidder during last 3 financial years should be not below than 50% of estimated cost.

The bidder should submit the certificate of turnover through <u>Unique Document</u> <u>Identification Number (UDIN)</u> duly certified by Practicing Chartered Accountant for preceding (last) 03 financial years on the basis of audited financial statement. ii. The bidder should have a "Net Worth" (which is defined as "Equity share capital + Reserves – Revaluation reserves – Intangible assets – Miscellaneous expenditure to the extent not written off and carry forward losses") of not less than <u>20% (Twenty percent</u>) <u>value of estimated cost of tender offered</u>. The bidder should submit the statement of Net Worth duly certified by Chartered Accountant for the <u>last financial year</u>.

The bidder should submit the statement of Net Worth through <u>Unique Document</u> <u>Identification Number (UDIN)</u> duly certified by the Practicing Chartered Accountant.

The bidder should have submitted the <u>Solvency certificate of 20%</u> of the estimated cost from any scheduled or Nationalized Bank. Also the certificate should not be older than last 06 months from the date of bid submission.

The duly audited, verified and certified figures from chartered accountant will be considered for annual turn over and net worth. The provisional certificates(if any) will be not be entertained.

4. OTHER MANDATORY DOCUMENTS FOR VALID BID:

- i. The bidder should complied/meet <u>MSETCL's required technical specifications mentioned in</u> <u>Annexure-"A".</u> The manufacturing of the equipment shall be strictly in accordance with the requirements of technical specification.
- ii. One set of documents incorporating the following particulars shall be included in the online offer- <u>GTP, BOM, Drawings, Technical literature/ Manual</u> for the offered equipment.
- iii. The bidder or his manufacturer should have <u>well established</u>, prompt after sales service-<u>support facility/network in India</u>. Necessary documentary evidence should be submitted along with the bid.
- iv. The price variation (PV) clause is not applicable for this SRM E-Enquiry.
- v. EARNEST MONEY DEPOSIT (EMD): online Mode only

- 2) Small-scale industrial unit permanently registered with Directorate of Industries Maharashtra for the manufactured items.

3) Small scale industrial unit registered with National Small Industries Corporation (NSIC) and Small Industries Services, Institute of Govt. Of India for the manufactured items.

The benefits mentioned in '1' to '3' above shall be available only to those items approved during the Registration process and subsequent updates in registration up to the date of submission of this SRM E-Enquiry. No interest shall be paid on the Earnest Money Deposit.

b. In the event the bidder withdraws his offer during the validity period the earnest money deposit shall stand forfeited and the Purchaser shall be entitled to recover the amount of E.M.D. paid or encashing the Bank guarantee or by resorting any other remedy available under the law.

NOTE FOR SSI UNIT: The bidder registered with Directorate of Industries of Government of Maharashtra for manufacturing the items tendered/offered and those who have attached valid Certificate at the time of vendor registration shall be considered for concessions applicable. These benefits shall be available only to those items approved during the Registration process and subsequent updates in registration up to the submission of this SRM E-Enquiry.

- c) Financial shortcomings or any failures in past contracts.
- d) Insufficient experience, or employing insufficient number of employees, or not employing the qualified employees.
