- 1) Duly filled, SEALED & FIRM Quotation in the name of The Superintending Engineer, EHV Project Circle, MSETCL, Aurangabad, super subscribing on the envelope with writing "Supply of Low Ankle ISI marked Safety Shoes (Conforming to IS-15298 &of Superior Quality, of Any Standard Make) of various sizes, under EHV Project Circle, Aurangabad", shall be submitted to this office, within 07 days, from the date of dispatch of enquiry i.e. On Or Before Dt. 05.09.2023, 13:00 Hrs.
- 2) Rate shall be quoted in consideration with Schedule-A. Rates quoted should be inclusive of all taxes. Only GST @ 18% will be paid extra.
- 3) Quantities mentioned in Schedule-A are tentative & may vary as per actual requirements of MSETCL.
- 4) Quality Materials shall be offered against said enquiry. You will have to submit sample of offered materials for necessary approval from the undersigned, along with the submission of quotation. Same will be returned after completion of sample approval procedure. With reference to quality of offered materials, decision of rejecting any or all of the quotations will be solely reserved by the undersigned. Same will be binding on you.
- 5) In case of variation in sizes of safety shoes as per actual requirements, same shall be got replaced by you within 08 days, at free of cost.
- 6) Conditional Quotation will be liable for rejection.
- 7) Offer must be Valid up to 90 days.
- 8) **Security Deposit:** - You will have to pay Security Deposit amounting to 10% of proposed value of work order by D.D./FDR in the prescribed format in favor of the Superintending Engineer, EHV Project Circle, Aurangabad valid for one year, before execution of works. Same will be

refunded after successful completion of guarantee period.

9) **Income Tax:** - Income Tax will be deducted as per prevailing rate.

10) **Agreement:** As per rules you have to enter into contract agreement on stamp paper costing Rs.500/- for this contract within 7 days from receipt of work order but before starting the work. Cost of stamp paper is to be borne by you. You can have draft agreement from this office which may be collected in advance.

- Copy of GST Registration Certificate
- Experience Certificate for having executed any Supply / Works involving Supply items in any MSETCL / MSEDCL Or Power Sector Utility.
