**TERMS & CONDITIONS:**

1. The supply is to be completed within 45 days from the date of receipt of supply order failing which you shall be liable for penalty at the rate of 1% of the value of order, per delayed week or such smaller amount as the undersigned may decide, subject to maximum 5% of total cost of order. Application for extension in time limit will have to be made in advance.
2. The rates should be valid for 60 days from the date of receipt of the quotations.
3. 100% payment will be made against receiving of bills from concern Hot Line Unit ,Ogalewadi as per availability of funds.
4. The bills in triplicate, advance stamp receipt should be submitted to concerned Hot Line Unit ,Ogalewadi incharge. Service entry will be made at Circle office.
5. You will have to pay the security deposit of 10% of the order value within Seven days from the date of receipt of firm order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work.
6. The quotations not confirming to the specifications are likely to be rejected.
7. The quotations should be properly sealed and super scribed on the envelopes as "Supply of various sizes of Rain Suits at Hot Line Ogalewadi office as per sample approved under EHV O&M Circle, Karad."
8. The insurance of your labours will have to be done at your cost. If failed to do so any compensation or claim arrears will be at your responsibility.

9. Following attested documents should be attested with the quotation.

  - b. Registration of firm under Bombay shop Act & Establishment Act.
