**TERMS AND CONDITIONS:**

1. The EMD and Tender fees is to be paid online on the account of MSETCL through website <https://srmetender.mahatransco.in>. **Due Date- 18.09.2023 upto 10:00 hrs.**

**Technical Bid.**

- Submit the performance/experience certificate along with work order for –
  - Proven record of successfully repairs/modification/installation/commissioning/AMC of various DG sets having capacity above 1600 kVA and their allied works in any public/private sector company.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the supply order mentioned in the experience certificate.

**Commercial Bid.**

- Income Tax Return for last one year.
- Average Turnover duly certified by Chartered Accountant should not be less than 60% of the estimated cost during the F.Y 2021 – 22. Certificate issued by Chartered Accountant must have 15 digit UDIN (Unique Document Identification Number) if issued on or after 01.04.2018.
- Net Worth of last Financial Year 2021-22 duly certified by Chartered Accountant (with UDIN) should not be less than 25% of estimated cost.
- Shop Act License
- Certificate of Registration for GST.
- PAN Card of the firm / proprietor as the case may be.

- List of T&P available with the agency for execution of the work.
  - The vender should visit the site before bidding for full acquaintance of the DG system.
3. The Contractor rates should be in percentage (%) based on estimate cost.
  4. Rates should be valid for 120 days from the date of commercial opening of RFX.
  5. Rfx fee is Rs.105/- including taxes (Is non refundable).
  6. If the above documents are not applicable then submit Eligible/ Non eligible documents list.
  7. Income Tax will be deducted from contractor's bill, as per Govt. rules.
  8. **Warranty** : 'The Contractor' will have to give a warranty / guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site / work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year the bidder shall give warranty of at least one year from the supply of material.
  9. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
- **Scope of work** : - The scope of work (B & C Checks) mentioned below is indicative and not a exhaustive one. Hence, additional work apart from scope mentioned below may have to be done.
- 1) Setting of fuel injection system of DG sets.
  - 2) Checking of air filter oil level.
  - 3) Cleaning and checking of Air Filter and replacement if required.
  - 4) Checking of fuel pump oil level.
  - 5) Checking of radiator/water tank level.
  - 6) Checking and replacement of coolant.
  - 7) Checking of fuel filter elements and its replacement if found faulty.
  - 8) Checking of lubrication oil filter and its replacement if found faulty.
  - 9) Checking of fan bel (Dynamo 7 water pump).
  - 10) Checking of major fasteners.
  - 11) Checking of control panel and protections.
  - 12) Checking of tappet setting.
  - 13) Greasing of various parts wherever points are given.
  - 14) No load trial for 10 mints and attending problems if any.
