1	<b>PRICES :</b>	The rates will be accepted as per Schedule A with work at various substation under EHV O&M Division, Kolhapur.
2	<b>SCOPE OF THE WORK :</b>	The work includes as per schedule A & as per the instruction of concern substation In-charge. Transportation of material and expert manpower will be at your cost only. Before starting of work joint measurement should be done with substation In-charge.
3	<b>TAXES :</b>	Rates are inclusive of all the taxes.
4	<b>SECURITY DEPOSIT :</b>	Security Deposit 5% of the order value submit to this office in form of Cash/BG/DD/Chq. The security deposit will be refunded only after completion of guarantee period & NOC from respective substation In-charge. <b>If BG is to be submitted Govt stamp duty of 0.1% of SD amount is to be paid.</b>
5	<b>SPECIFICATION :</b>	Work should be carried out as per specification in enclosed Schedule 'A'
6	<b>RISK &amp; COST:</b>	In case you fail to complete the work fully or partly, the balance work will be completed from other agency and difference in cost will be recovered from your bill and security deposit in this case will be forfeited to Company.
7	<b>QUANTITY &amp; QUALITY :</b>	Quantity & Quality as per schedule A & Specifications.
8	<b>INCOME TAX :</b>	As per govt. rule Income tax at source will be recovered from your bill as per rules. Your Income tax No. may be informed to this office

10	<b>WORKING PERIOD</b> :	The work should be completed within 15 days from the date of handing over of site.
11	<b>PENALTY FOR LATE WORK</b> :	In case of work is not completed as per schedule in specified time, the contractor shall be liable to pay penalty @ ½ % per week subject to maximum 10% of order value.
12	<b>DEDUCTION</b> :	Any amount or amounts which become payable by the contractor to the MSETCL under particular contract may be deducted by the purchaser from any amount / amounts due or becoming due by him to the contract under the same or any other contract.
