TERMS & CONDITIONS :

- 1. DUE DATE :-** The quotation completed in all respect, duly sealed & super scribed should be submitted to this office either in person/post on or before **Dtd.21.09.2023 upto 18:00 Hrs** positively.
- 2. DOCUMENTS TO BE SUBMITTED ALONG WITH OFFERS :-** Please submit the following documents along with offer :
 - 1.** Income Tax Return for Last 02 Financial years.
 - 2.** Registration under PAN & GST.
 - 3.** Registration under Bombay Shop & Establishment Act/NOC from local Grampanchayat.
- 3. ESTIMATED COST :-** The estimated cost is limited upto **Rs.55650/-** including of all.
