**TERMS AND CONDITIONS:-**


- 1) The sealed & super scribed quotations are invited for work of appointment of consultant for work of Preparation of proposal for collecting as a build details by physical verification on the field against shifting of 33KV Padghe-Malegaon Tr. Line for NHSRCL's under EHV Projects Division, Kalyan under EHV Projects Division, Kalyan.
- 2) Submit your quotation against this Enquiry during period from Dt. 15.09.2023 to 22.09.2023
- 3) The Quotations (on firms letter head) along with required documents complete in all respect i.e. should be filled in Schedule "A" duly signed, sealed & super scribed shall be submitted to this office on or before 22.09.2022 up to 15:00 Hrs.
- 4) Scope:- As mentioned in schedule A.
- 5) The scope of work mentioned in schedule-A should be completed within 02 Months from the date of receipt of LOA.
- 6) Estimated cost :- Rs. 9,67,600.00 (Inclusive of all taxes).
- 7) 5% amount against security deposit will required to be paid before starting the work. Security deposit will not be deducted from your bill in any case.
- 8) AGREEMENT:- Successful bidder will have to execute agreement as per provisions under Maharashtra Stamp Amendment Act 2015. Stamp duty charges shall be borne by bidder.

1.1	The bidder should be registered under GST Act under GOI as well as for other various taxes in force.
1.2	The Bidder should provide proof of registration of firm under Bombay shop & establishment act, PAN No.
1.3	The Bidder should have basic infrastructure for consultancy for obtaining NOC from various forest departments. List of Skilled personals along with qualifications.
1.4	Bidder should have experience in consultancy for obtaining NOC from various forest departments.
<b>2.</b>	<b>Financial Criteria :-</b>
2.1	Average Annual financial turnover during the last 3 financial years ending 31st March of the previous financial year should be at least <b>60%</b> of the estimated cost. In support of this the bidder shall submit the annual audited report certified by the statutory auditor in case of company. OR by the chartered accountant where accounts are not required to be audited under any law.
2.2	The bidder should have Income Tax returns of last three financial years (e.g. Year 2019-20, 2020-21 & 2021-22) with Pan card copy
<b>3.</b>	<b>Technical Experience Criteria :-</b>
3.1	The bidder shall have experience of preparation and processing forest proposals and obtaining approval from forest authority.
3.2	The bidder must have experience of having successfully completed similar works during last seven years. <b>Note--</b> For all above works, satisfactory work completion certificate/ final approval copy of forest proposal is mandatory.


