EMD amount of **Rs. 9,85,103.58 /- @ 1% of estimated cost** will have to be paid by the bidder through online mode only. **OR** The bidder will have to furnish Bank Guarantee/DD of any nationalized/ scheduled Bank in prescribed format equivalent to 1% of the estimated cost in lieu of bid security deposit in the name of Superintending Engineer, EHV O&M Circle, Amravati payable at Amravati at the time of submission of bid documents with validity of 8 months from the date of opening of techno-commercial bids.
