Sealed percentage rate quotations are invited from Govt. registered & experienced Contractors for the above work as per schedule enclosed. The quotation should reach to the office of Executive (Civil) EHV CCCM Division Mahatransco Administration Building, first Floor, wing no.102, Chhatrapati Sambhajanagar on or before dated.19/10/2023 Time 16.30 Hrs.

TERMS AND CONDITIONS:

1. The work should be carried out as per the schedule/ P.W.D. specification/ instructions of the Engineer in-Charge and to the satisfaction of the undersigned.
2. The rates in the schedule are inclusive of all taxes, cost of all material, labour, plant, equipment, temporary works, tools, setting out, supervision, transportation taxes, GST, royalties, octroi and any local state or central taxes or levies payable on all transactions, insurance, labour cess, and everything necessary for due completion and proper performance of all works under the contract.
3. The quantities mentioned in the attached schedule are approximate and likely to vary. However payment will be made as per the work actually executed and measured. The rates shown in enclosed schedule B are inclusive of GST.
4. The work should be completed within (1) MONTHS from the date handing over the site, failing which the contractor shall be liable to pay as compensation an amount equal to one percent or such similar amount as the competent authority may decide of the W.O. cost for every day the work remain unfinished after due date of completion subject to the maximum 10% of the cost of the order.

5. The work which is of bad workmanship quality will not be measured and paid.
6. Other resources for execution of the work such as required tools and plant will have to be arranged by the contractor at his own cost.
7. The contractor will have to make good the damages if any made by him during the execution of work at his own cost.
8. Income Tax as per the prevailing income Tax rule and subsequent amendment thereof will be recovered at source of your bill on total value of work done for which the certificate will be issued if desired.
9. The successful bidder shall submit for approval two samples of proposed the Architectural drawing (Plan /Elevation/section/3view)duly signed by him ,in triplicate, on the paper of size A0. Apart from this ,the contractor shall submit the soft copies of these drawing in PDF format as well as in Auto Cad format. Such drawings shall be as per prevailing byelaws. MSETCL shall review the drawing so submitted and will suggest the revision if it deem necessary. In such case ,the bidder shall submit the final revised drawings without any additional cost to MSETCL in aforementioned format. The successful bidder shall then submit the estimate once the Architectural drawings are approved in triplicate as well in excel format.
10. Contractor will be held responsible for accident occurred during the course of the work and will have to pay the compensation as per the act 1923 and subsequent amendment thereof.
11. Contractor should submit his bill in triplicate through Addl. Executive Engineer (Civil) EHV CCCM Sub-Division-II, MSETCL,Chhatrapati Sambhajinagar to the undersigned.Payment will be made within 30 days period from the date of receipts of bill to this office.
12. The terms and conditions in the M.S.E.T. Co. Ltd. Booklet 'Tender and contract work' will stand applicable for this work.
13. You will have to deposit **Rs.9,800/-**(5% of quotation value) as security deposit in cash/ DD/FDR of any nationalized Bank within 7 days from the date of receipt of work order, failing which EMD will stand forfeited.
14. The contractor's offer will be considered as inclusive of all taxes and charges and it will be the contractor's responsibility to pay the taxes to Government and same will not be reimbursed to the contractor.
15. Your own offer should be quoted in words and figures scratches and over written rates shall not be considered if not initialed.
16. The contractor has to pay earnest money to **Rs. 2,000.00/-** in cash/RTGS/NEFT/In form of DD/FDR of any Nationalized Bank in favor of Executive Engineer(C) EHV CCCM Division, MSETC Ltd. Chhatrapati Sambhajinagar. If the EMD of required amount is not found in the envelop the quotation will be rejected. 17. The undersigned reserves the right to reject any or all quotations without assigning any reason what so ever.

18. The GST, Income tax, labour cess shall be recovered from the bill of the contractor as per prevailing labour laws.
19. As per revised circular issued by Dy. Directorate of Insurance Maharashtra State, the successful bidder shall, apart from other relevant insurance, submit labour insurance amounting to 0.5% of the work order value , to EHV CCCM Division Aurangabad before starting of the work. The insurance cover shall be procured by the contractor from Dy. Director of insurance, Maharashtra State.
20. Special condition: The payment shall be effected as per fund availability. Due to shortage of fund there are chances of delay in payments for which the agency will have to bear with the Dept. No. any of claim on this account will be entertained.
21. The estimated cost of the work is **Rs.1,95,700.64/-** only. (Inclusive of all Taxes)
