CIRCULAR INVITING QUOTATIONS FOR WORKS:

Sealed and super scribed quotations are invited for the works as detailed in Schedule 'A' enclosed herewith subject to following terms and conditions.

- **1. Name of work:** Work of replacement of 145KV 'B' Phase Bushing of 132/33KV 25MVA, BBL Make T/F No. 4 at 132KV Phaltan S/Stn. under EHV O&M Division Karad.
- 2. Estimated Amount: The estimated amount is Rs. 1,48,581.00 including all taxes.
- 3. Rate Validity: The rates should be valid for 60 days from the date of receipt of the quotations.
- **4. Submission of bills: -** The bills in triplicate, advance stamp receipt should be submitted to Division office.
- **5. Payment of bills: -** 100% payment will be made against receiving of bills from concern authority as per availability of funds.
- 6. Security Deposit: You will have to pay the security deposit of 5% of the order value within Seven days from the date of receipt of firm order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work.
- 7. Due date: The quotations should reach to this office on or before 17.11.2023 up to 15.00 Hrs.
- 8. The quotations not confirming to the specifications are likely to be rejected.
- 9. The quotations should be properly sealed and super scribed on the envelopes as "Work of replacement of 145KV 'B' Phase Bushing of 132/33KV 25MVA, BBL Make T/F No. 4 at 132KV Phaltan S/Stn. under EHV O&M Division Karad."
- **10. Insurance:** The insurance of your labours will have to be done at your cost. If failed to do so any compensation or claim arrears will be at your responsibility.
- **11.** Following attested documents should be attested with the quotation.

1. Certificate of Registration of firm **2.** GST registration copy. **3.** Valid Electrical Contractor's License. **4.** Income Tax Return for last Three Assessment years i.e. 2020-21, 2021-22 & 2022-23.

5. The bidder should have an experience certificate from an authority not below the rank of Executive Engineer for the work of replacement of 145KV Bushing in last three years. (Experience certificate compulsory).

- **12. Taxes:** The taxes should be quoted separately, otherwise it will be presumed that your rates are inclusive of all taxes.
