**Terms and Conditions:**

Following are the site conditions and Monopoles are required to suit the site condition.

- 1) Monopole should be of Regular type and the spans between two poles ranges between 250 - 350 mtrs.
- 2) Soil type along the route is DFR & BC.
- 3) 0.4 ACSR (Zebra) conductor is to be used, thus monopole should be designed considering this conductor stringing.
- 4) Work is to be so planned & executed that it should be completed in minimum outage plan.
