- 1) Restricted bids from already qualified bidders from previous respective tenders.
- 2) Bidders are requested to quote the revised price schedule considering the revised clause of Non-applicability of PV clause for a period of 01 year. Based on the L1 rates received for each category of tenders, other participating bidders will be asked to match the price with L1 bidders.
- 3) Bidders are requested to quote on % basis i.e. (at PAR or % below or % above) of above estimated rates.
- 4) Price variation clause as per IEEMA formula will not be applicable to Copper, Insulating materials and Labour charges for new scheduled rates for A1 to A5 category.
- 5) There will be no deviations for these tenders.

**Sub:** Fixing of Schedule of Rates (SOR) for Repairs of EHV Power Transformers, ICTs and Reactors of various capacities & voltage ratings in MSETCL for a period of 01 (one) year without price variation implication. **-Approval for IFB thereof.**
