- 1) **<u>DUE DATE</u>**: The bids complete in all respects should be submitted online on or before 02.12.2023@ 13:00 Hrs. positively.
- SCOPE OF WORK: Work of partial discharge testing of 400/132kV 200 MVA Kanohar Make ICT-II Sr.No.KT200000/2 due to rising trend of Hydrogen gas at 400kVRS Division Khadka-Bhusawal.
- 3) **<u>OUOTED RATES</u>**: The rates quoted are including of all taxes, charges, etc.
- 4) **SECURITY DEPOSIT:** The successful bidder will have to pay an amount equivalent to 5% of Contract value towards S.D. at Executive Engineer, 400kV R Division Khadka-Bhusawal, within 15 days from the date of receipt of LOI which is refundable after satisfactorily completion of guaranty period.
- 5) <u>AGREEMENT</u>: Agreement contract between MSETCL & successful bidder should be carried out on Rs. 500/- bond paper within 15 days from the date receipt LOI. Successful bidder will have to borne the charges for agreement bond.
- 6) **VALIDITY OF OFFER:** The offer should be valid for our acceptance for a period of 90 days from the due date of this SRM E-Enquiry.

- 7) **<u>DELIVERY PERIOD</u>**: work carried out at an earliest within 30 days from the date of work order.
- 8) **<u>TECHNICAL QUALIFYING CRITERIA</u>**: The rate offer must be accompanied with following documents by vendor:

<u>Technical bid (Qualifying Requirement)</u>: Bidder should upload the following digitally scan copies of original documents / certificates online in 'note & attachments' tab in RFx.

1. <u>Statutory Qualifying Requirement/Criteria:</u>

- 1. The Bidder or his associates should have a valid Govt. Electrical Contractor's license.
- 2. The Bidder should have a Proof of registration of firm under **Bombay shop & Establishment** Act under company's Act.
- 3. The bidder should have Valid Workmen Compensation policy.
- 4. The bidder should have Copy of PAN Card.
- 5. The bidder should be registered under Goods & Services Tax Act (GST).

Note: The original colored scan copy should be uploaded as bid documents in support of statutory qualifying criteria i.e. statutory licenses/registration. The attested / notarized photo copies of the same will not be entertained.

2. <u>Technical Qualifying Requirement/Criteria:</u>

- i. The bidder should have in last **07** years experience of "Similar type of relevant work i.e. Partial Discharge testing of ICT for amounting as follows;
- a. One completed work mentioned above having costing not less than the amount equal to 70% of the estimated amount, **OR**
- b. Two completed works mentioned above having each costing not less than the amount equal to 40% of the estimated amount, OR
- c. Three completed works mentioned above having each costing not less than the amount equal to 30% of the estimated amount.
- ii. The bidder should have proven experience not less than 7 years of similar type of work.
- iii. The bidder should submit the end user's Certificate for <u>successful completion of work at least</u> for 7 years as on the date of submission issued by the authority not below the rank of Executive Engineer or Equivalent with detail work order copy.
- iv. The owner reserved the rights to accept / reject the Bid.

Note: The original colored scan copy should be uploaded as bid documents in support of Technical qualifying criteria. The attested / notarized photo copies of the same will not be entertained. Detailed communication address, e-mail ID and contact nos. of the end users should be furnished for cross verification.

3. OTHER MANDATORY DOCUMENTS FOR VALID BID:

- i. The price variation (PV) clause is not applicable for this SRM E-Enquiry.
- ii. EARNEST MONEY DEPOSIT (EMD): online Mode only

The bidder should have to submit the <u>proof regarding payment of SRM E-Enquiry fee & E.M.D.</u> @1% of estimated cost.

The bidder shall pay the Earnest Money Deposit as set below along with the SRM E-Enquiry. The SRM E-Enquiry without the payment of Earnest Money Deposit shall be summarily rejected.

- **c.** In the event the bidder withdraws his offer during the validity period the earnest money deposit shall stand forfeited and the Purchaser shall be entitled to recover the amount of E.M.D. paid or encashing the Bank guarantee or by resorting any other remedy available under the law.
