The LOA/work order will be placed on final accepted price for (Supply + ETC) works including GST & Duties.

Price Variation i.e. PV on Taxes & duties if any will not be payable.

For extra quantities if any, rate shall be as per approved MSETCL SOR for the year 2022-23 or as reasonable.

Bidder should submit the all Schedules duly signed and filled with relevant information

2.0 The brief scope of the work will be as under :

- a) Supply of required equipments & other allied materials as per standard specification mentioned and as per the approved vendor list as mentioned in supply schedule/as per Approved Vendor list published on MSETCL website.
