**TERMS AND CONDITIONS:**

1. The EMD and Tender fees is to be paid online on the account of MSETCL through website <https://srmetender.mahatransco.in>. **Due Date- 12.12.2023 upto 10:00 Hrs.**
2. Document should upload the following digitally signed scan copies of documents /certificates online under

**Technical Bid.**

- Submit the performance /experience certificate along with work order for “*Providing & Fixing of Bird guards for 220kV and above lines*” in any Govt/Private sector in india.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.

**Commercial Bid.**

- The bidder shall submit the copy of PAN card along with bid. The Bidder shall submit the copy of Income Tax returns for the last three Financial years, from the last day of month previous to the one in which Tenders are invited.
- The bidder should be registered under GST Act. The Bidder shall submit the copy of GST returns for the last Financial year from the last day of month previous to the one in which Tenders are invited.
- The bidder should have a valid Electrical Contractor's License issued by the Government of Maharashtra for work of erection/commissioning of EHV equipment.
- The bidder should have the Minimum Annual Average Turnover (MAAT) of at least 60% of tender estimated cost in the last three years i.e. 36 months.
- The bidder should have a Net worth (which is defined as “Equity share capital+Reserves-Revaluation Reserves-Intangible assets- Miscellaneous expenditure to the extent not written off and carry forward losses”) of last financial year, from the last day of month previous to

the one in which tenders are invited, not less than 25% (Twenty Five Percent) value of tender estimated cost. The bidder should submit the state of Net-Worth duly certified by Chartered Accountant with seal and UDIN.

- The bidder should have to submit the audited financial statements i.e. profit & Loss account and Balance sheets for last three financial years duly certified by Chartered Accountant with seal and UDIN.
- Shop Act License.

3. The Contractor rates should be in percentage (%) based on estimate cost.

4. Rates should be valid for 120 days from the date of commercial opening of RFX.

5. Rfx fee is Rs.118/- including taxes (Is nonrefundable).

6. If the above documents are not applicable, then submit Eligible/ Non eligible documents list.

7. Income Tax will be deducted from contractor's bill, as per Govt. rules

8. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.

**9. Scope of work: -**

Scope of work includes providing & fixing of non-conductive, rotary (Turbo Wind Driven) Conical type of Bird guards for 400kV Babhaleshwar-Padghe Ckt- I & Ckt-II Double ckt lines under Padghe Sub divisions under the jurisdiction of Rajgurunagar division for the FY 2023-24.

10. Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company in the approved proforma on stamp paper of Rs. 500/- (Five Hundred Only) at your cost as per the D.O. ltr no. Mudrank-2009/2707/Pra.Kra./326/M-1 dtd 09.10.09. and Co.'s Adm. Circular no. 207 dtd 17.04.10. Until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, for the work executed under the contract.

11. Before issue of work order, the contractor will have to pay security deposit of @ 10% (Ten) of the order value on any scheduled, private or nationalized bank **either by-**

**i) F.D.R. or D.D.** drawn in favor of MSETCL, Padgha **or by RTGS**

**ii) B.G.** drawn in favor of MSETCL, Padgha.

Same will be refunded after expiry of order period. No interest will be paid on this deposit.
