- 2.** The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR the work of Supply & Erection of Light Mast Tower (21 Meter height) at 400KV RS Kumbhargaoon, (Nanded). The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule "A" format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. - 3. Quoted Rate:** The bidder has to submit percentage bid for the particulars mentioned in Schedule "A".
- 4. Important Dates:** Quotations invited from **16.12.2023 from 10:00 Hrs**, so as to reach this office up to **22.12.2023 up to 18:00 hrs** and the same will be Opened on the same day, if possible. - 5. Order value:** The Order value is limited to Rs. 7, 23,288.0/- (In Words: Rs. Seven Lakhs Twenty Three Thousand Two Hundred & Eighty Eight Only) inclusive of all taxes.
- 6. Taxes:** Taxes will be paid & recovered, as per rules.

7. **Payment:-** On completion of work, agency to submit the bill in triplicate (Indicating PAN No., GST Reg. No.) along with MOM & test certificates (if any), and advance stamp receipt, towards AEE, 400 kV S/s Maint. Unit Kumbhargaoon, Nanded, who will record the bill as per actual work done.
8. **Paying Office:** - No advance payment shall be made in any case. However payment against this contract will be effected by Executive Engineer, 400 kV R S Division Kumbhargaoon, Nanded within reasonable time as per funds availability & after satisfactory completion of work.
9. **Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD to the office of the Executive Engineer, 400 kV R S Division Kumbhargaoon, Nanded from the date of issue of order.
10. **Signing of Contract:-** Agreement contract between MSETCL authority & you should be carried out on Rs.500 bond paper within 7 days from the date of receipt of the work order. You will have to borne the charges for agreement bond.
