Executive Engineer, EHV Line Projects Sub Division - I, Bapat Camp, Kolhapur as per the Schedule 'A' attached herewith subject to following terms & conditions.

TERMS AND CONDITIONS :

- 1) The quotations should reach to this office on or before **08/01/2024 upto 16.00 Hrs.** This office shall not accept any responsibility for late receipt of quotations due to postal delay.
 - a) **Rate :** The rate quoted shall be on firm basis and shall be inclusive of All taxes excluding GST.
 - b) All the taxes including wheel tax, town duties, comprehensive insurance and any other statutory tax applicable. (However the incidentals such as parking charges, toll/ entry tax etc will be borne by the user).
 - c) The services of the Driver.
 - d) Only Diesel shall be supplied by MSETCL.
 - e) The normal working duty of the vehicle is from 09.00 to 19.00 hrs or 08.00 to 18.00 hrs as fixed by vehicle incharge with one hour recess period for the Driver.

- 2) **Vehicle / Registration :**
 - a) The vehicle should be in good running & fairly comfortable condition i.e. tyre, all meters, cushion, wiper etc. must be in working and good condition.
 - b) The vehicle must have RTO registration, requisite Tourist permit for travel in Maharashtra, GOA & Karnataka as per MSETCL requirement valid for the period of contract.
 - c) The vehicle registration must be after 1st March 2017. However, preference will be given to latest model/manufacture.
 - d) The vehicle must have comprehensive insurance policy Third Party Insurance will not be acceptable.
 - e) The normal weekly off is Sunday, however in exceptional cases the vehicle shall be made available on Sunday/ Holiday in exigency.

- f) The driver posted on the vehicle should possess valid driving license with minimum 3 years experience and should be courteous in behavior and good natured. In case of change of Driver prior approval of the concerned in charge Engineer should be obtained.
- g) The following documents/details of offered vehicle shall be submitted alongwith the quotation,
- i. Type of the Vehicle & its Registration No., Model, Type, Year of Mfg.
 - ii. Registration certificate/R. C. Book.
 - iii. Tourist and or taxi permit bearing 'T' mark or goods permit wherever required.
 - iv. Public carrier permit from statutory authorities, Road Tax Certificate.
 - v. P. U. C.
 - vi. GST registration certificate if registered.

Any quotation not accompanied with the above documents shall be rejected.


- h) The quotation should accompanied with copy of PAN Card and GST registration if applicable.
