- 1) Scope of work: Work of Shifting of various scrap materials from godown to Storeyard at Major Stores, Panvel as per schedule 'A' only. The work should be purely as per instructions of the Executive Engineer. The bidder should carry the survey and understand the scope of work before bidding.
- 2) The prescribed form i.e. Schedule 'A' duly signed & filled with rates in words and figures should be sent by registered post or in person to the office of the Executive Engineer Major Stores, Panvel.
- 3) Please super scribe the offer with the following details:

- 4) Bidder should not submit conditional quotations. Such conditional offers shall liable for rejection.
- 5) The bidder should submit following self attested documents/certificates with quotation:
- 1) Provide proof of registration of firm under shop & establishment Act/NOC from Grampanchayat.
- 2) GST registration certificate if applicable
- 3) PAN card
- 4) ITR certificate for last three years.
- 5) Work experience certificate for similar type of works in power sector/private sector/Government undertaking (In category of similar type of works such Shfting, loading & unloading of material by Hydra crane etc.)

The bidder should submit experience in the similar works as under:

• One similar completed works in single order mentioned in schedule or mention above and scope of work having costing not less than the amount equal to 80% of the estimated cost.

OR

• Two similar completed works in two orders mentioned in schedule or mention above and scope of work having costing each not less than the amount equal to 50% of the estimated cost.

OR

• Three similar completed works in three orders mentioned in schedule or mention above and scope of work having costing each not less than the amount equal to 40% of the estimated cost.

Bidder has to submit latest experience certificate of years 2017 on words for above mentioned works with satisfactorily/successfully completion remark signed by the authority not below the rank of Executive Engineer

The owner reserves the right to review the bidder's performance in MSETCL or any other sector and may accept / reject the offer in part or full accordingly.

- 6) Undertaking to be submitted by the bidder declaring that bidder is not debarred/blacklisted by government/semi government/ other power utilities. Format of undertaking is as per given in Enquiry Documents.
- 6) The rates quoted should be firm and price variation will not be applicable. The offer quoted shall be valid for 120 days. Bidders are requested to please make a note that in case of ambiguous terms in respect of condition, taxes or if the blanks are not filled in, the offer/ quotation shall be liable for rejection.
- 7) The Estimated cost includes all the labour charges, supply of material require for execution of work, tools & plant, GST, Labour cess. So it is requested to quote the rate considering the all above charges.
- 8) Quotation which do not fulfill all or any of the qualifying conditions or are incomplete in any respect are liable to reject.
- 9) Right to cancel any or all the bids/offers without assigning any reason thereof is reserved by the undersigned.

TERMS & CONDITIONS

1. The bidder is expected to visit the site, and get familiar with the site. The bidder shall make own arrangement of transport, labours, all tools and tackles etc.

2. SCOPE OF WORK:

- a) Shifting & stacking of ACSR conductor jumpers with attached hardware from Godown No. 13 to Storeyard.
- b) Shifting & stacking of 80 Sqmm AAA Conductor from Godown No. 12 to Storeyard.
- c) Removing of decomposed wooden base of 18 Nos. 245KV CTs by lifting up with the help of crane.
- d) The contractor shall make his own arrangements for vehicles, labour, tools and tackles, handling equipment's, adequate capacity cranes etc. at his cost for execution of the work detailed herein.

3. TOOLS PLANTS AND MACHINERY:

The contractor shall have sufficient and adequate T&P with him. The representative or authorized representative of the MSETCL will verify the workability & availability of T&P owned by contractor. If the inadequacy is observed, contractor should comply all short falls after written consent of in-charge.

4. HOUSING AND ACCOMMODATIONS:

Contractor will make his own arrangement for the housing of his staff and labours.

5. COMPLETION TIME:

The Successful bidder will have to complete the entire work in all respect within one week from date of LOA/work order or exhausting of amount whichever is earlier.

- 6. Work contract agreement on stamp paper of Rs.500/- is to be made. The cost should be borne by agency only.
- 7. The total work order value is Rs, 41,147/. Due to small amount of work, security deposit will not be charged.

8. LIQUIDATED DAMAGES:

- a) If the contractor fails to complete all the works within the time frame stipulated, the MSETCL shall levy liquidated damages for breach of contract.
- b) The Liquidated damage shall be levied at the rate of ½ % (Half Percent) on the total contract price per week of delay, subject to the maximum of 10 % of the contract price for the entire scope of the work.
- c) In case of such delay, the contract may be terminated by the competent authority as per general rules and regulations of MSETCL and the balance work shall be got completed through separate contract at his risk and cost.
- d) GST will be charged extra @18% on calculated LD Amount.

- 9. The rates indicated in the schedule are firm and no price variation will be payable on any account. GST, TDS and Labour cess as applicable will be deducted from your bill.
- 10. The quantities indicated in the schedule are approximate and only indicative. However the payment will be done for the actual work done.
- 11. 100% GST Payment will be made against the GST tax invoice submission along with GSTR1 & GSTR3B challan copies.
- 12. GST, income Tax and all other taxes will be deducted from your bill as per govt. privilege rules from your bills.
- 13. You should quote your PAN/GST number on bill otherwise your payment will be delayed.
- 14. Labour Cess: Labour cess @ 1% will be deducted from your bill.
- 15. Bills in triplicate alongwith should be submitted to the Executive Engineer, Major Stores, Panvel, after satisfactory completion of work.
- 16. 100% payment will be made within a reasonable time from the Office of The Superintending Engineer, EHV (O&M) Circle, Panvel against certified bills from the Engineer- in-Charge of Major Stores, Panvel
- 17. If any damages occur to the MSETCL's Property through your personnel during execution of this work, you will have to make it good at your own cost.
- 18. You shall not effect or transfer the work order partly or fully to any other agency.
- 19. The undersigned reserves the right to cancel the order or part of it without assigning any reason.
- 20. Notwithstanding anything stated herein, the MSETCL's general terms and conditions of contract shall be applicable to this work also.
- 21. All disputes, differences related to this contract shall be subject to the exclusive jurisdiction of Raigad District court.
