- 2) <u>Nature of work:</u> Engaging Attendant on outsource basis at Regional Training Center, 400KV R.S. Division, Jejuri.
- 3) The bidder should quote rates in % only ..The bidder should quote basic price exclusive of GST & GST should be quoted separately in appropriate field. The Estimated cost is amounting to Rs. 2,92,397 /-inclusive GST.

- 9) The persons should remain present in office on working days and shall not leave the office or company representative without prior permission.
- 10) The contractor will be solely responsible for any accidents either fatal or non- fatal occurred to your persons during the course of work, the compensation arising due to this is to be borne by you.
- 11) The contractor is solely responsible for compliance of statutory obligation under shop and establishment act, contract.
