With reference to the above, you are requested to please quote your lowest rate on or before 15.01.2024 up to 13:00 Hrs. Stipulated in Schedule "A" (Enclosed herewith) under the terms & conditions laid down hereunder.

### Terms & conditions:

- 1) Two separate sealed envelopes, one consisting rate quotation and other with technical documents should be submitted. Sealed envelope duly super scribed with all details i.e.
  - (i) E-Enquiry No & Date :-
- (ii) Due date :-
- (iii) Quotation for
- 2) The rates should be quoted for hiring charges on per day basis; exclusive of all taxes and any other contingencies etc.
- 3) Income tax at source as per rules will be deducted from bill as per the prevailing rates.
- 4) The mileage per liter of the vehicle should not be less than 11 km/ ltr.
- 5) The Quotation must be written with ink or typewritten, any scratching or over writing must be initialed.
- 6) The period for hiring of vehicle will normally be upto one year from the date of engagement of vehicle, however if MSETCL's vehicle is allotted by CO Mumbai the hired vehicle will be discontinued by giving 15 Days notice.
- 7) Only fuel (i.e. Diesel) will be supplied by MSETCL; no extra charges will be paid for vehicle driver, repairs, oil & all other taxes & duties.
- 8) The rates quoted should be valid for at least one year from the date of placement of order or actual use of vehicle.
- 9) The Working hours will be normally from 07:00 to 18:00 hrs on working days. However, in case of emergency, it will be required beyond 18:00 hrs or before 7:00 hrs & on holiday also. But no overtime charges or halting charges for the vehicle will be paid.
- 10) Vehicle maintenance, arrangement of driver and his salaries and allowances or any other expenditure will be borne by vehicle owner.

- 11) In case of accident of vehicle total responsibility lies only on the agency.
- 12) PID work T&P will be required to carry in the vehicle, so same should be allowed.
- 13) Any kind of vehicle breakdown should be attended by owner. The driver should have valid license to drive such type of vehicle.
- 14) All the provisions under rules and laws regarding registration of vehicle, taxes etc. should be borne by vehicle owner.
- 15) If it is found that vehicle is not giving satisfactory service, the contract is liable for cancellation in that case.
- 16) Vehicle should be able to use on country roads in Nashik & Ahmednagar district and all over Maharashtra if required, where EHV sub-stations/ lines are present.
- 17) In case of failure of vehicle due to any reason, the vehicle owner has to provide another same type of vehicle on same rates & terms condition without any delay.
- 18) The Company's general conditions and contract are also applicable and will be binding on you. Vehicle will be engaged after inspecting by the undersigned.
- 19) The responsibility of comprehensive insurance, PUC, taxi permit & RTO formalities will be with vehicle provider.
- 20) While submitting the offer following vehicle documents shall be submitted in separate sealed envelope.
  - a) Vehicle fitness certificate.
  - b) Valid Insurance of the vehicle.
  - c) RC/TC book with tax paid details
  - d) Valid PUC Certificate.
  - e) Contract Carriage permit (Tourist Permit)
  - f) Driving License.
  - g) Pan card
  - h) GST Certificate (if applicable).
- 21) Payment will be effected on per month basis within reasonable period as per availability of funds.
- 22) Preferably Vehicle should not be more than 5 years old, incase it is more than 5 years old vehicle will be accepted only after inspection of undersigned or authorized representative of undersigned.
- 23) The undersigned reserves the right to accept or reject quotation in part or full without assigning any reasons thereof.
