

- 2. Validity of Offer :-** The rates should be valid for **60 days** from the date of receipt of the inquiry.
- 3. Due Date :-** The Schedule "A" duly filled in with the rates quoted as percentage above/below / at par of our estimated rates will be submitted by registered post or in person to the Office of the Executive Engineer, EHV Projects Division-I,Pune on or before **23.01.2024 up to 18:15 Hrs.**This office shall not accept any responsibility for late receipt of quotation due to postal delay.
- 4. Consignee :-** The material should be delivered at the office of Deputy Executive engineer, 132kV Rasta peth substation,Pune.
- 5. Security Deposit :-** You will have to pay the security deposit of **5%** of the order value within Seven (7) days from the date of receipt of firm order. Security Deposit is payable by (a) Cash (b) D.D (c) Cheque. The S.D. will be refunded after satisfactory completion of the work after one month.
- 6.** Payment will be made at EHV Project Division Office, Pune after completion of 100% work carried out by the contractor for all approved works executed as fixed by the Engineer after scrutiny and certification of bills at concerned EHV Line project S/dn, Pune Office.
- 7. Guarantee :-** Manufacturer's guarantee certificate along with guarantee of installation work for 1 year should be provided by the agency at the time of installation of AC.
- 8.** The contractor has to execute the agreement on stamp paper as per Govt. rule, before commencement of work.
- 9.** All T & P, Labour etc. shall be arranged by the contractor at his own cost.
- 10.** The contractor shall make his own arrangements for the installation of Air Conditioner.
- 11.** The quotations not confirming to the specifications are likely to be rejected.

17. Labour welfare cess / GST / other statutory payment etc. considered in contract value will be deducted at appropriate rate prevailing during tenure of contract.


