- 1) **Warranty**: The material offered should carry company's warranty against any deficiency in material or workmanship. Company and model name of the tyre should be mentioned in the quotation.
- 2) **Delivery Period**: The work should be supplied within **30 Days** from the date of issue of supply order to this office.
- 3) **Penalty**: If you fail to supply the material in time, penalty at 1/2% per week or part thereof will be levied on you on the cost of material which are supplied late subject to maximum 10% of the total value of the this order, However due consideration will be given in lieu of penalty for the reasons absolutely beyond your control which documentary evidence will have to be produced by you.
- 4) **Payment of Bill**: Suppliers will be paid 100% payment of the contract price along with all taxes against delivery. The bill should be submitted to this office in triplicate. The Payment will be made with reasonable time by EHV O&M Circle, Karad.
- 5) **Specifications**: The tyres offered should strictly conform to the specifications. If the same is not conforming, then the quotation will be rejected.
