## **TERMS & CONDITIONS:**

- The rate in % should be quoted on firm quotation basis. 1.
- The schedule A duly filled in with the rates quoted as percentage above/below/ at 2. par of our estimated rates will be submitted by registered post or in person to the office of the Executive Engineer, EHV Project Division-I, Pune on or before 29.01.2024 up to 18:15 hrs.
- The vehicle must be spared for hire along with driver and fuel charges. 3.
- Vehicle shall be driven by contractors Driver. The Driver shall be well 4. behaved, neatly dressed and possessing valid driving licence.
- The fuel i.e. diesel or electric vehicle charging cost and also cost of lubricating oils 5. i.e. engine oil, break oil and other spares/maintenance will be born by agency.
- Monthly expenditure of vehicle including fuel/electric charging is restricted to the 6.

- 7. All R.T.O. permissions, registrations, tourist permit, insurance & taxes shall be the responsibility of the contractor & MSETCL will not be responsible for same. Valid Xerox copy of each above mentioned documents with attestation, PAN card, GST registration copy ,Fitness certificate, PUC,driving licence,Road tax paid receipt,Professional tax paid receipt, shop act licence should be enclosed with quotation. If in case GST is not applicable declaration on letter head should be enclosed.
- 8. Per day duty will be of 10 hrs. including one Hour recess(9.00 to 19 hrs). For extra hours beyond this, overtime will be paid as per actual.
- 9. Night halt charges shall be shown separately.
- 10. In case any accident, mishap & breakdown occurs all the liabilities will be at contractor's cost & risk & alternative arrangement for the vehicle shall be made by him immediately on basis of same terms and conditions. Also alternative arrangement for the driver shall be made by him immediately. In case the ordered vehicle is off the road due to failure/repairs either for short period or long period alternative vehicle of similar condition on basis of same terms and condition shall be provided by him immediately.
- 11. Vehicle must be kept in good running condition. Vehicle model should have manufacturing year preferably during last 5 years.
- 12. The vehicle must run on all types of roads. The indispensable stephny must be provided with the vehicle. Also the overall condition of vehicle must be in working condition.
- 13. Kilometer reading will be taken where the vehicle first reports for company's duty and where it is left last. Empty running between parking place will not be paid by the M.S.E.T.C.L.
- 14. It will not be binding on the company to provide parking space for the hired vehicle inside or outside the company premises after duty hour.
- 15.. Bill will be paid every month for actual working day's and contractor will have to submit the bill in triplicate through the Add.EE, S and I S/dn, Pune
- Duration of hiring of vehicle is approximately up to 31.03.2025 from the date of engaging the vehicle. If departmental vehicle is available or MSETCL does not discontinued with a prior notice of 15 days to you.

- During halt at other place, the driver should arrange his own kits. 18.
- All the maintenance charges of vehicle, salary, travelling allowance and other 19. benefits of the Driver will be born by the contractor. No any other charges are paid to you except mentioned in the Schedule A. such as toll charges, parking charges etc will not be paid by MSETCL.
- You have to execute the agreement for hiring of vehicle with the company on 20. Rs.500/-, after receipt of work order/LOI. The cost of stamp stamp paper of paper will be born by you.
- You will have to pay S.D.at the rate of 5% of value of the contract by Bank 21. Guarantee/F.D.R. of the Work order value within 07 days from receipt of work order/LOI.
- In case of the difference of opinion about the interpretation of terms and conditions between the contractor & M.S.E.T.C.L. the decision of the undersigned will be final 22. & binding upon the contractor.
