- 1) **DUE DATE:** - The quotations complete in all respects, duly sealed & super scribed should be submitted to this office from 25.01.2024 to 01.02.2024 up to 13:00 Hrs positively.
- 2) **QUOTED RATES:** - Taxes & Charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.
- 3) **SECURITY DEPOSIT:** - The successful bidder will have to pay 5% of total work order value towards S.D. at EHV (O&M) Division Office Babhaleshwar.
- 4) **VALIDITY OF OFFER:** - The offer should be valid for our acceptance for a period of 2 year from the Due date of same.
- 5) The rates should quote on per day basis & the average Km/Ltr should not be less than 12km/Ltr.

- 6) No extra charges will be paid for vehicle driver, repairs, oil & all other expenses including accidental damages if any.
- 7) The vehicle should be in good condition & not more than 05 year old (i.e. manufacturing year of vehicle shall be Jan-2019 onwards & the vehicle prior to year Jan- 2019 will not considered),
- 8) The vehicle should have valid "T- permit" & Valid Fastag.
- 9) The period for hiring of vehicle will normally be 12 months from the date of engagement of vehicle, however if MSETCL vehicle is allotted by C.O Mumbai the hired vehicle will be discontinued by giving 15 days notice.
- 10) The responsibility of comprehensive insurance, PUC, tax permit & RTO formalities will be with vehicle provider.
- 11) Separate vehicle diary/Logbook will be maintained by the contractor for the account of diesel Km. run/day etc. for hired vehicle.
- 12) Payment will be effected on per month basis within reasonable period after recording in Measurement Book by concern officer Incharge.
- 13) Quotation must be submitted along with the attested Xerox copies of all the documents pertaining to the vehicle such as i) Vehicle registration documents ii) Vehicle Fitness Certificate iii) Valid vehicle Insurance iv) Valid 'T' permit, v) Valid PUC vi) Driving License etc. vii) PAN Card copy viii) Valid Fastag etc.
