E-Enquiry Notice

Subject: E-Enquiry for Hiring of Non-A.C. LMV Vehicle (TATA SUMO or equivalent) with driver at Line Maintenance Sub-Division Hingoli, under EHV (O&M) Division, Parbhani for the period of 01.04.2024 to 31.03.2025.(2nd call).

Dear Sir / Madam,

Sealed & Super scribed quotations are hereby invited, by undersigned, for the Work of Hiring of Non-A.C. Vehicle with driver at **Line Maintenance Sub-Division Hingoli**, under EHV (O&M) Division, Parbhani for the period of 01.04.2024 to 31.03.2025. Submit the sealed quotations to this office between 30.01.2024 to 07.02.2024; 12:00 Noon.

The Other Terms & Conditions are as follows:

- 1. Considering the works at subdivision level, the vehicle is allotted for works at site as per MSETCL needs & same shall be suitable for accommodating manpower, tools & tackles. This vehicle is supposed to be used for LMSD staff for works purpose. The vehicle shall be suitable for accessing remote area, area having level differences & shall have more ground clearances. As such, LMV Vehicle TATA-SUMO or equivalent vehicle is required.
- 2. Quotations should be duly filled in all respect & sealed envelope to be submitted to this office, within due date.
- 3. Rate shall be quoted, exclusive of taxes, in Schedule-A. The rate quoted shall be valid for 180 days from the date of opening the quotations.
- 4. GST will be paid extra, as applicable.
- 5. Enclose duly attested & signed copies of following valid documents, along with quotations:
 - Vehicle Registration Certificate Vehicle Tourist / Taxi Permit
 - Driver with Valid Driving License Valid Vehicle Insurance
 - Valid PUC Certificate Valid Vehicle Fitness Certificate
 - Valid Shop Act Registration Certificate
 - PAN Card & GST Registration Certificate if registered agency.
 - Proof of payment EMD Rs 3,000/- (in words rupees three thousand only). **Quotation submitted** without EMD will be rejected.
 - Duly signed Annexure-A with declaration from contractor on letter head of agency.
- 6. The envelope containing quotation should be properly sealed & subscribed Quotation for:

"Hiring of Non-A.C. LMV Vehicle (TATA SUMO or equivalent) with driver at Line Maintenance Sub-Division Hingoli, under EHV (O&M) Division, Parbhani for the period of 01.04.2024 to 31.03.2025."

- 7. No extra charges will be paid for Vehicle driver, oil, other taxes & duties etc. Repair, Maintenance of vehicle is in the scope of agency. Only Toll tax will be paid by MSETCL, as applicable.
- 8. The fuel (Diesel) charges to be borne by MSETCL with condition that the vehicle should give minimum average of 12 km/Ltr without AC. Manufacturing date of vehicle should not be prior to Year 2017.
- 9. Agency will be responsible for comprehensive insurance, PUC, taxi permit, RTO & other Legal formalities at their own cost.
- 10. The hiring period of the LMV shall be 01.04.2024 to 31.03.2025 only, however if MSETCL vehicle is allotted then the hired vehicle will be discontinued by giving 15 days' notice.
- 11. Payment of EMD: Agency will have to pay an amount of Rs 3,000/- as EMD and same will be returned after finalization of work order and furnishing the security deposit. EHV(O&M) Division Parbhani Bank account details can be collected from F&A section during Enquiry period. The EMD may be forfeited in the case of:
 - (a) If the bidders withdraw or revise his offer during the period of Bid validity OR
 - (b) <u>If the successful bidder i.e. qualified 1st lowest bidder fails to execute the agreement & deposition of work order security deposit within 7 days from the date of issue of the Letter of Intent
 </u>
- 12. Security Deposit: Security Deposit i.e. 5% of Order value is to be paid after the issue of work order but before actual deployment of vehicle to the Line Maintenance Sub-Division Hingoli, under EHV (O&M) Division, Parbhani, from the date of issue of work order. Same will be refunded after satisfactory completion of work order. In case of failure to execute work order in full or part, security deposit will be forfeited.
- 13. Payment will be effected on per month basis within reasonable period subject to availability of funds.
- 14. Quotation submitted along with all necessary vehicle duly attested documents. No conditional quotations or quotations in part are allowed.
- 15. Jurisdiction of hired vehicle will be all over Maharashtra. Hired vehicle will be kept at MSETCL Line Maintenance Sub-Division Hingoli.
- 16. Agency will have to submit duly signed copy of Annexure-A i.e. declaration from contractor with quotation, otherwise bid will be rejected.
- 17. Undersigned reserves the right to place work order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever. In normal course, the interpretation of the undersigned on any matter or decision given by him on any disputable points will be final and binding on you.
- 18. In the event of any disputes regarding the work order for this work, the decision of the undersigned shall be final & binding upon the contractor.
- 19. MSETCL will not accept conditional bids.
- 20. Notwithstanding anything stated here, the terms and conditions stipulated in the Booklet of Board's General Terms & Conditions of Contract will also form a part of the contract and will be binding on you wherever it is not specifically mentioned.
